# Mayor to quit Wardmember bids for post

STOUFFVILLE - Eldred King's moving up; Gordon Ratcliff's moving out.

That's the situation following a press statement, Friday, by Mayor Ratcliff and an announcement, Monday, by ·Councillor King, related to Arthcoming municipal elections, Nov. 13.

"It's been six rewarding years. I gave it the best I had," Mayor Ratcliff told The Tribune.

The mayor recalled saying, back in 1976, he wished to serve only one more term in office. Just over three months remain. "The Town's been good to me - centennial year, I'll never

forget it," he stated. It was after serving many years on public and high school boards, that Gordon Ratcliff entered municipal politics as a councillor in the Twp. of Whitchurch. When regional government was introduced and Whitchurch and Stouffville became one, he continued on as a councillor in Ward 4. He was acclaimed mayor in 1973 and has held the position ever since. The job has had its rewards,

not the least of these, the challenge of drawing the urban and rural communities together. "To this end, I think I've been successful," he said. Other accomplishments he likes to look back on include - the building of a new public library; the coming of McNeil

Police said the northbound transport, driven by Randall John Corless of Agincourt, failed to stop for a red light and collided with an eastbound gravel truck, driven by Kenneth Duncan, 29, of Downsview. It then veered out of control and slammed into four cars all stopped in two southbound

Killed in the collision was Wilson Trowbridge, 36, of Keswick. Seriously injured was Faye Lowe, 52, also of Keswick, a passenger in the Trowbridge auto. Others hurt included,

Robert Petick, 31 of Newmarket and his passenger, Kenneth Madsen, 32 also of Newmarket. Petick suffered a fractured neck, a broken jaw and internal injuries. Madsen suffered a broken pelvis and a crushed chest. Kenneth Duncan was

treated for a fractured shoulder and back injuries.

Rather, he stressed, its purpose is to help individuals who could be experiencing problems in certain areas.

local Board The representative said every teacher serving his or her probationary period (two years), is evaluated at least once. He said the school is made fully aware of the day an officer will call and the teacher in question receives a full appraisal report once its prepared.

"Nothing's hidden," the trustee stressed.

In total, 711 reports were filed in 1977-78, but not on 711 different teachers, Mr. Bowes said. He admitted that some dismissals had occurred, but always following close consultation between the 'inspector'; the school principal and the area superintendent.

Seeks re-election

Harry Bowes, Board of Education member for Whitchurch-Stouffville, will seek reelection for another two-year term. He'll also let his name stand for the chairman's post in 1979. He's currently the Board's vice-chairman.

On occasions, he noted, one of the three officers will visit a school at the principal's request and sometimes to do an appraisal on teachers with more than two years' experience.

At a recent meeting of the Board, the supervisory program was discussed at length. At the conclusion, Sam Chapman, Director of Education stressed the fact that "it is not the job of the supervisory team to "weed out" poor teachers, but to eliminate poor teaching by identifying where it is and helping him or her to either leave the improve or profession".

Rather than being too tough on teacher personnel, trustee Don Cameron considered the program not tough enough. "It bothers me," he said, "that within our schools, the personnel system isn't as tight as in the business world".

In outlining the supervisory process, it was explained that if a teacher's performance is deemed unacceptable, the principal may request the officer to make a return visit at a later date. The principal, the report read, is responsible for making every effort to help the teacher improve and for writing reports showing the degree of improvement.
