Lloyd Grove of Bailieboro, Ont., and formerly of R.R. 1, Stouffville, topped the class with a first, two seconds and a third. Herb Jarvis, Sheppard Avenue East, Agincourt, was the runner-up with a first, two thirds and a fourth.

They'll compete for the Canadian Title in New Brunswick next fall.

"Fantastic" was the way Lloyd Grove described the outcome of the event, saying entries with two-furrow plows were always considered to have a definite edge.

"The result set everybody on their ear," he said, "we weren't expected to win". At the awards banquet, Friday, he received an engraved trophy; a set of silverware; an engraved plaque; a gold wristwatch and a

set of luggage. His prize money will total \$750.

Herb Jarvis has been a participant in International competition since 1937, first with horses and since 1962 with tractors. Just prior to the "big match" at Wingham, he recalled two men predicting "the day would never come when a 3-furrow plow would beat out a two".

"It did," he said, "a lot sooner than anyone thought". With reference to Lloyd's first place finish he commented,

"it couldn't have happened to a better man".

While the provincial champions held the spotlight, other plowboys from the area fared well too. Eric Timbers, R.R. 4, Stouffville won two firsts; two seconds and the class championship for 15 to 17 year olds. Others scoring firsts or in the top three were — Carl Timbers, Barry Timbers, Bryan Degeer, Ted Smith, Kevin Grose, Don Dunkeld and Floyd Forsyth.

Eric Timbers and Ken Wells were runners-up for the County Team Title.

victimized by thieves, following

Virginia Arbuckle and her husband criticized the court system in York and claimed they'd been treated to a "snow job" by police.

The Commission was told that a stationwagon, containing musical equipment, was left outside the dance hall only a short time. Later, the owners discovered the vehicle missing.

The culprits in this escapade, damaged two violins when they used them to smash in a glass door panel.

Mrs. Arbuckle said the Police Department was notified but no investigation was started until eight days later. She told the Board that neither she nor her husband was notified that the instruments had been recovered nor were they given an opportunity to speak to the court regarding damages. She estimated the loss at \$1,500.

Restitution, she said, was in the amount of \$300.

The complainant stated that in order to find out the amount of damage done to their car, she had to call police in the Region of Durham where the vehicle had been impounded.

She was most upset, however, over the fact police had relied solely on statements made by the accused rather than allowing her to testify.

Commission chairman, Judge Wm. Lyon attempted to explain that because the offenses were of a criminal nature, they were committed against the State rather than the individual. He said Civil Court was the place to recoup losses.

In explaining the incident further, the chairman said the car-owners had left the keys in the ignition and the motor running, a fact, member Gladys Rolling called "a bit negligent".

Judge Lyon said the Board was sympathetic to the couple's problem. "I know victims sometimes think they don't get a fair shake," he said.

Several angry ratepayers threatened law suits and court injunctions over the affair. Ratepayers' chairman, Barry Gray submitted a petition saying his group would be seeking "such legal action as may be appropriate or possibly by way of court injunction or otherwise" to stop the gravel pit proposal.
