

# Married seven months Pit accident shatters dream

WHITCHURCH — Brian and Denise Thorn were married Aug. 25 of last year. But they had no honeymoon. Instead, they spent their spare time establishing their new home at Prince Albert near Port Perry. That seemed more important to them then.

An extended holiday was planned for this year, a trip into the Poccino Mountain region of south-east Pennsylvania. But that dream was shattered, last week, when Brian was killed in a freak accident on the property of Pit Haulage Limited, Bloomington Sideroad, west of Hwy. 48. The 26-year-old man, well-known in the Stouffville area and highly respected among co-workers, died instantly when a portable crusher, weighing about 45 tons, tipped forward, pinning him beneath.

There was nothing unusual about the job, pit owner Paul Sabiston told The Tribune, in fact both the victim and site foreman, Bud Doucette had moved the machine many times without incident.

Both men, he said, were experts in handling equipment, maintaining an accident-free record since the pit first opened nine years ago.

This love of heavy machinery was recalled by Denise. "That was part of what he lived for," she said, remembering how he spent two months attending a course at

Thunder Bay so he could perform his duties even better.

He also enjoyed the outdoors, assisting with any chores that needed doing on her father's dairy farm. He was quiet spoken, she said, "a wonderful person".

This opinion was shared by all those attending the service, Saturday afternoon, filling the Port Perry chapel of McDermott-Panabaker to overflowing. The floral tributes were beautiful.

Rev. Clifford Pendlebury,

the minister at their marriage, conducted the funeral with interment, Hillman Cemetery, Ufca. The pall bearers were Ron Batty, a close friend who travelled here from Peace River; Paul Sabiston, Bud Doucette, Keith Doucette, Michael Bedore and Chris Tolley.

Surviving besides his wife are his mother, Dorothy Thorn of Stouffville, a sister, Debra (Mrs. Neil Crawford) of Port Perry and a brother, Allan, also of Stouffville.

## Ex-deputy nabs escapee

YORK REGION — Once a policeman, always a policeman. Former deputy-chief-turned-Liberal-candidate Wally Harkness proved this last week when he apprehended a prisoner making a bid for freedom outside the old court building in Newmarket.

The male accused was being led to a cell in the basement when he suddenly bolted through an open door leading to the fire escape. From the steel stairs, he jumped onto the hood of the paddy wagon and then to

the ground. If the prisoner had reached Main Street, he might have been on his way. However, he came to the end of the line when he ran into the open arms of Harkness.

As an aftermath to the escapade, two officers required medical treatment for injuries. Constable Tom Wauchope, formerly of Stouffville, suffered a broken hand when the cell door was slammed on his fingers and Constable Alfred Garvey suffered bruises when punched in the face.

## Gormley's fate revealed soon

GORMLEY — The Board of Transport Commissioners will meet soon, possibly this week, to decide the fate of the east-west Stouffville Road through the hamlet of Gormley.

Ron Moran, regional councillor for the Town of Markham said a progress report on the appeal had been received

indicating a decision possibly by April 15.

The original recommendation called for the closing of the road at the C.N.R. crossing, forcing residents east of the tracks to take the bypass route to the north. Many within the hamlet opposed this, claiming it would create a

hardship for persons wishing to attend Sunday services at the Missionary Church. They also said it would divide the community into three separated sections.

Mr. Moran said he's hopeful the Board will at least approve a pedestrian cross-over so persons living east of the tracks won't feel completely cut off.

## Livestock rescued

WHITCHURCH — Fast action by the owner and his helper, saved four horses, three cows and a four month old St. Bernard pup from certain death, Friday, when fire destroyed a barn on the property of John Murphy, R.R. 4, Stouffville.

Mr. Murphy and his assistant, John Robinson, had time to release the animals before flames enveloped the building. The loss has been

estimated at \$50,000.

The blaze, attributed to a faulty furnace, was first observed around 10 a.m. With no telephone there, several minutes elapsed before the alarm could be sounded. The house is some distance away and was never in danger.

John Murphy, the owner's son, had an apartment in the barn's second storey and lost everything including clothing, school books and furniture. A

student attending Seneca College, he had gone to the family's cottage at Midland the weekend.

Stouffville's three fire units were assisted by two tankers from the Town of Markham. Extra water was pumped from a nearby pond.

John Robinson was the only casualty. He suffered a broken finger while attempting to release one of the horses. He was also stricken with what is

known as hyper-ventilation, but recovered quickly.

At the height of the blaze, Chief Walter Smith had to caution several of his men against venturing too far into the building. It was feared they might be trapped should the roof collapse.

The Murphy's moved to the property, called Bran Oak Farms, in November '78. The previous owners were Vince and Ruth Love.

## Plan switch in schools

GORMLEY — A boundary change that, if approved by York County Board of Education, will see fifty students transferred from Dickson's Hill Public School to Crosby Heights in Richmond Hill with the start of the fall term in September.

The shift, accorded almost unanimous approval at a public

meeting, Thursday night, will increase the enrollment at Crosby Heights to about 550. The school can accommodate up to 600.

To alleviate the attendance drop at Dickson's Hill, children from Markham's Mint Leaf Subdivision, will be bussed to classes there. New homes are now under construction in that

development with thirty-five school-age children anticipated by September.

The change in boundaries will affect pupils in the area of Gormley and Victoria Square. The district under discussion extends from Hwy. 404 on the west to a mid-point between Concessions 4 and 5 on the east and from Major Mackenzie

Drive on the south to the Stouffville-Gormley Road on the north.

Bill McVicar, Superintendent for Area 2 said parents at Victoria Square are particularly pleased since they relate more to Richmond Hill than Dickson's Hill. He noted too that graduates from Crosby Heights are automatically enrolled at Bayview Secondary.

However, one mother spoke out against the move, expressing a desire to have her children continue at Dickson's Hill and later attend high school in Stouffville. Mr. McVicar said this could be arranged.

The superintendent informed the audience that academic programs at the two elementary schools were basically the same. He praised the teachers at both, saying that extra staff would be required at Crosby to handle the larger enrolment.

The Board is expected to deal with the matter some time this month, McVicar said.
