IN THE MATTER OF an application by The Regional Municipality of York for approval to exprepriate the land described in Schoole "A" herete annexed, in the Towns of Markham and Whitchurch-Steelfville all in The Regional Municipality of York termorty in the Township of Markham in the County of York, for or in connection with:

(1) The widening of Regional Road No 67 (7th Line, McCowan Road) in the Towns of Markham and Whitchurch-Stoutfville from a point approximately 600 feet south of the more southerly intersection of 16th Avenue and Regional Road No. 67 (7th Line, McCowan Road) in the Town of Markham to a point approximately 2000 feet south of Regional Road No. 14 (Stouffville Road) in the Town of Whitchurch-Stoutfville to a basic width of 100 feet with additional widenings at cuts, fills and intersections; and

(2) The elimination of the jog in 16th Avenue at Regional Road No. 67 (7th Line, McCowan Road) in the Town of Markham by realigning and widening 16th Avenue from a point approximately 200 feet west of Regional Road No. 67 (7th Line, McCowan Road) to a point approximately 1,000 feet east of Regional Road No. 67 (7th Line, McCowan Road) to a basic width of 86 feet with additional widening at the listersection with Regional Road No. 67 (7th Line, McCowan Road); and

(3) The elimination of the jog in 18th Avenue at Regional Road No. 67 (7th Line, McCowan Road) in the Town of Markham by realigning and widening 18th Avenue from a point approximately 200 feet west of Regional Road No. 67 (7th Line, McCowan Road) to a point approximately 1,000 feet east of Regional Road No. 67 (7th Line, McCowan Road) to a basic width of 66 feet with additional widening at the intersection with Regional Road No. 67 (7th Line, McCowan Road); and

(4) The elimination of the jog in 19th Avenue at Regional Road No. 67 (7th Line, McCowan Road) in the Town of Markham by realigning and widening 19th Avenue from a point approximately 400 feet west of Regional Road No. 67 (7th Line, McCowan Road) to a point approximately 1,200 feet east of Regional Road No. 67 (7th Line, McCowan Road) to a basic width of 86 feet with additional widening at cuts, fills and the intersection with Regional Road No. 67 (7th Line, McCowan Road); and

(5) The construction of culverts, drainage works, including stream realignments, and all other related works and undertakings in connection with the foregoing highways.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described in Schedule 'A' hereto. Any owner of land in respect of which' notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.

(a) in the case of a registered owner served personally or by registered mail, within thirty days after he is served with the notice, or, when he is served by publication, within thirty days after the first publication of the notice;

(b) in the case of an owner who is not a registered owner, within thirty days after the first publication of the notice.

NOTES:

...1. The Expropriations Act provides that, (a) Where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Minister of Justice and Attorney General: (b) The inquiry officer.

(i) shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent, and (ii) may recommend to the approving authority that a party to the

inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.

"owner" and "registered owner" are defined in the Act as follows: "owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested;

"registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper registry. land titles or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment roll. The expropriating authority, each owner who notifies the approving authority

that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry officer are parties to the inquiry.
