Ballantrae Fun Fair Raise \$5,000

BALLANTRAE — School and community "togetherness" was never more apparent than here, Thursday night.

A Fun Fair that included a public auction and lottery, raised over \$5,000. The receipts will be used to establish a computer learning centre in the school.

"It was a co-operative effort all the way through," staff teacher Georgia Berry told The Tribune, "the support was incredible."

It was Principal John Laughlin who came up with the idea back in the spring, Mrs Berry said. A committee of teachers was formed that included Mary

Storey, Donna Friedbacher, Liz Cameron, Joan Wideman, Pat Tribou, Marg Crichton and Mrs Berry. They, along with a host of parents, arranged the event. The 73 items in the auction were all donated as were four lottery prizes. A pair of skis from Old Firehall Sports Limited in Unionville were won by Gloria Schader, Ballantrae; a pine blanket box by Nathan Matchett, Toronto and fitness club memberships by Irene Fockler, R.R. 3, Stouffville and Barbara Fockler, R.R. 4, Stouffville.

The auction, that included everything from a propane torch to a dozen donuts, was in charge of well-known area auctioneer, Cec Stickwood. His services, like the articles he auctioned, were provided without charge.

One item, that attracted considerable interest, included two Argo football tickets and a giant teddy bear. Rod Byers

was the successful bidder. His price—\$70. The seven-pound Hershey chocolate bar brought \$33.

Mrs Berry said that when all receipts are in, funds should be sufficient to purchase three and maybe four computers. Four teachers are presently enrolled in a computer course provided in Aurora through York University. Delivery of the units to Ballantrae School is expected shortly, she said.

Mrs Berry said Ballantrae could have waited in line and eventually received delivery through the Board of Education. This, she said, could have taken three or four years "so we decided to go it alone".

In addition to the raising of funds, she said the Fair had kindled closer co-operation between the school and the community. "In one way or another, just about every parent was involved," she concluded.

Urea Formaldehyde

Our tax loss over \$88,000



STOUFFVILLE — Tax concessions being offered as relief for those who used urea formaldehyde to insulate their homes, will mean a revenue loss to Whitchurch-Stouffville of \$88,929, Council has learned.

The Borough of Etobicoke has asked the Town to join in a petition to Cabinet requesting some relief in this matter. However, Councillor Tom Wood voiced opposition, saying he was opposed to petitions from other municipalities. He suggested instead, that such requests go through regular channels. But Councillor Wm. Kamps, the acting mayor, claimed extra distribution of the appeal by means of a petition, could prove beneficial.

"They're just looking for publicity," maintained Councillor Wood. His argument was supported by Councillor Charles Warden who recommended the request go through the Association of Ontario Municipalities.

Councillor Wilf Morley suggested a delay of at least a year could occur by going through the Association and Councillor Jim Rae remarked that he understood some of the recipients were pleased with present arrangements. However, the request was eventually supported.

Council also approved a request to government for legislation to control trail bikes. Several members expressed concern at the destruction these machines were causing, even in grain fields.

Postal Simplification

The Town of Richmond Hill is seeking support to have postal boundaries simplified, eliminating small centres.

Councillor Charles Warden voiced approval, pointing to the fact his telephone is on the Aurora exchange, he lives in Whitchurch-Stouffville and his mailing address is R.R. 2, Gormley. He said he found it all

very confusing.

Councillor Wilf Morley was opposed, saying small hamlets would lose their identity. Morley was supported by Councillor Kamps.

Councillor Jim Rae said it was unlikely the government even thought of such a thing when the system was established. The request was rejected.

Extra train if needed

STOUFFVILLE — The addition of second GO-train between Stouffville and Toronto is a "definite possibility", Ontario Transport Minister James Snow told The Tribune this week.

Mr Snow, in announcing plans concerning a long-range transit system for The Golden Horseshoe, (Oshawa-Hamilton), told The Tribune that, although he was unable to confirm anything at the moment, an extra train was being considered. The Golden Horseshoe plan will include commuter service between Oshawa and Pickering.

"We only have enough cars and equipment right now to offer one on each line," the minister said of the Stouffville circuit. "A change will depend on the number of riders and the service required."

He said a second train, leaving a half-hour earlier or a half-hour later, would be an asset.

Snow said Stouffville hadn't been included in the initial "long-range plan", but rather was added to make the town a part of the GO-system.

He said present budget limitations would prevent an immediate change.

A freak accident

GORMLEY — A 21-year-old Gormley area man was killed, Thursday, in a freak accident at a driveway entrance on Bayview Avenue, Richmond Hill.

Police said William Isaac Hughes of Leslie Street, R.R. 2, Gormley, was operating a pickup truck and stepped out of the vehicle, leaving it in neutral gear.

When the truck began to roll ahead, Hughes attempted to jump back in the cab. However, the driver's door struck a tree, pinning the victim against the side.

It was twenty minutes before anyone noticed the accident. The Gormley man was pronounced dead on arrival at York Central Hospital, Richmond Hill.
