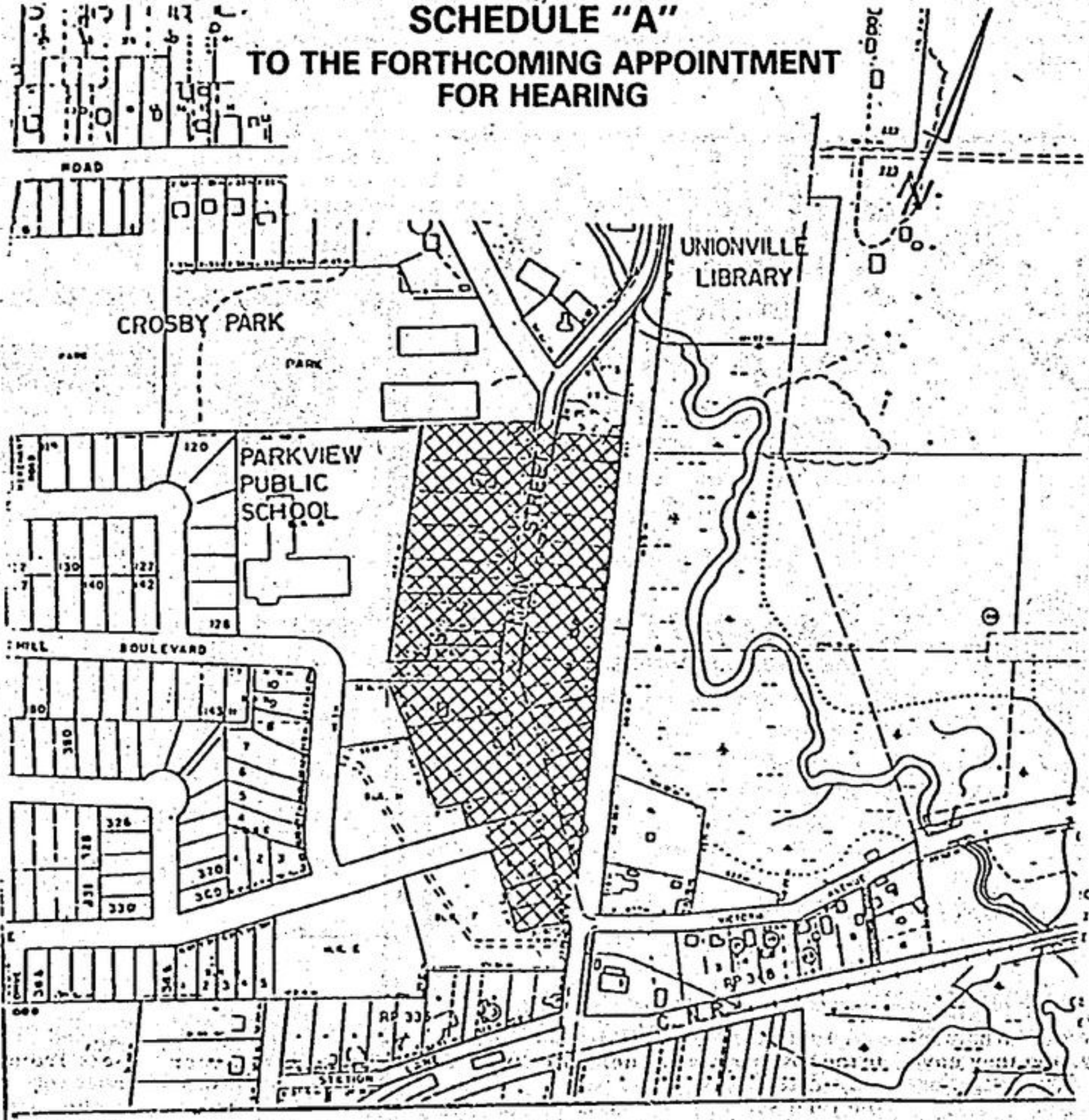

**PROPOSED BY-LAW OF THE CORPORATION OF THE TOWN OF MARKHAM**

A by-law to amend By-Law 169-83 Designating an Area in the Unionville Business District of the Town of Markham as an Improvement Area pursuant to Section 217 of The Municipal Act, R.S.O. 1980, Chapter 307.

WHEREAS the Council of the Corporation of the Town of Markham at its meeting held on the 28th day of June, 1983 passed By-Law 169-83 to designate an area in the Unionville Business District of the Town of Markham as an Improvement Area pursuant to Section 217 of The Municipal Act, R.S.O. 1980, Chapter 302, subject to the approval of the Ontario Municipal Act;

AND WHEREAS Notice of Council's Intention to include the property on Part of Lot 12 and 13, Concession 5, Town of Markham, more particularly described as Part 2 on Plan of Survey 64R-6931, municipally known as 209 Main Street North, Unionville, which property is occupied or the land is used for the purpose of or in connection with a business and is shown on the last revised assessment roll of the Town of Markham as being assessed for business purposes within the meaning of The Assessment Act, in the area of the Unionville Business District of the Town of Markham designated as an Improvement Area by By-Law 169-83 passed by the Council of the Corporation of the Town of Markham at its meeting held on the 28th day of June, 1983;

AND WHEREAS Notice of Council's Intention to pass a by-law to include the property on Part 2 on Plan of Survey 64R-6931 as Part of the Unionville Business District Improvement Area was given on the 27th day of September, 1983 in accordance with the provisions of Section 217(2) of The Municipal Act, R.S.O. 1980, Chapter 307;

NOW THEREFORE the Council of the Corporation of the Town of Markham hereby enacts as follows:

1. THAT Schedule 'A' to By-Law 169-83, designating an area of the Unionville Business District of the Town of Markham as an Improvement area pursuant to Section 217 of The Municipal Act, R.S.O. 1980, Chapter 307, be amended by including in the area to be designated as an improvement area the property described in Schedule 'A' attached hereto, being Part of Lot 12 and 13, Concession 5, more particularly described as Part 2 on Plan of Survey 64R-6931, municipally known as 209 Main Street North, Unionville, such property being occupied or the land being used for the purpose of or in connection with a business and shown on the last revised assessment roll of the Town of Markham as being assessed for Business' Assessment within the meaning of The Assessment Act;
2. THAT all other provisions of By-Law No. 169-83 passed by the Council of the Corporation of the Town of Markham at its meeting held on the 28th day of June, 1983, be and the same are hereby ratified and confirmed;
3. THAT the provisions of this by-law shall come into force and take effect on the date of its approval by the Ontario Municipal Board.
