# ANNOUNCING A CANADA SAVINGS BONDS RATE INCREASE!

Effective June 1, 1984,  
the rate of return on the last two series of  
Canada Savings Bonds (\$37 issued November 1982 and \$38  
issued November 1983) has been increased to

# 10 $\frac{1}{4}$ %

per annum

for the 5-month period  
ending October 31, 1984.

This means that bonds of these two series (\$37 issued November 1982 and \$38 issued November 1983) earn interest at the rate of 9 1/4% per annum for the 7 months which began November 1, 1983 and 10 1/4% per annum

**SERIES 37 AND 38 RATE INCREASE**  
Both Regular Interest Bonds and Compound Interest Bonds of these two series earn the new rate of return. As a result, each \$1,000 Regular Interest Bond will now pay \$96.67 interest on November 1, 1984. In addition to simple interest at the rates stated above, Series 37 Compound Interest Bonds earn compound interest at the rate of 9 1/4% per annum for

the 5 months beginning June 1, 1984. The rate of return payable beginning November 1, 1984 will be announced when the terms of the new 1984/85 Series are made public in October.

With this increase, the annual value of a \$1,000 Compound Interest Bond of these two series will grow as follows: These values are based on minimum rates guaranteed from November 1, 1984 to maturity: 8 1/2% for Series 37 and 7% for Series 38.

### ALL OTHER OUTSTANDING SERIES

All other outstanding unmatured series remain unchanged. Bonds of these series continue to earn interest at the rate of

10 1/4% per annum. This rate of 10 1/4% is also the minimum rate for subsequent years to maturity.



### Palais Records incorporates

## Markham company makes mark

A fledgling Markham record company is spreading its wings as it launches a video and becomes an incorporated business.

Palais Records has tagged a 'Limited' at the end of its name and is producing a follow-up record and video to their successful first record, 'Real Men/Let Me Sooth You,' by Canadian artist Yvonne Moore.

"The first record did well, it got us national attention," says Steven Ducas, co-owner.

Yvonne Moore won the Canadian Dance Music Award for most promising female vocalist this year. She was also nominated for top female vocalist and song of the year:

Her new record, an EP (extended play) called 'Hit 'n Run Lover,' is scheduled to be released June 15 and will appeal to a wider market, according to Mr. Ducas.

"It's definitely dance music, but with a little more pop," he says. "I expect it to do well on American stations."

The video is produced by Mark Obradovich who has worked on videos for Chilliwack and choreographed by Stelio Caligaris, who also worked on a video for hit singer Sherry Keane.

Recorded at Nova Sound Studio on Don

Park Rd., the record is produced by Rory Slater and arranged by John Itaba, both partners in the company.

The company has been doing well since its inception 10 months ago. "We're negotiating with outside investors for further expansion," says Mr. Ducas. "And we're selling shares in the production."

He has high expectations for the new record.

"It will do great, the response to the preview was good, and the video will help," he

says, explaining they are aiming for the Michael Jackson market. "He's one of the biggest record-sellers of all time."

With the added attraction of a video, Mr. Ducas expects the record to do well in Canada as well as the United States where dance music is more popular.

He points out the recent success in Canada of a song called 'Automatic' by the Pointer Sisters which features music similar to the new Yvonne Moore record.

That type of music is hot," he says.
