**THE EXPROPRIATIONS ACT NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND**

IN THE MATTER OF an application by The Corporation of the Town of Whitchurch-Stouffville for approval to expropriate land being part of Lot 2, Con' 9, shown as Parts 9 and 10 on Reference Plan 65R-6846 in the Town of Whitchurch-Stouffville in the Regional Municipality of York, for the purpose of:

The provision of additional access and for accommodating services to the Recreation Centre from the road allowance known as the 9th Line at a point about the North-East corner of Lot 7, Registered Plan 59 adjacent to the North of Lot 7, Plan 59 and extending from the 9th Line to the Recreation Centre a distance of about 59.938 metres by a width of about 20.349 metres and being part of Lot 2, Concession 9, shown on Reference Plan 65R-6846 as Parts 9 and 10.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described as follows:

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Whitchurch-Stouffville in the Regional Municipality of York and being composed of Part of Lot 2 in the 9th Concession of the said Town of Whitchurch-Stouffville, shown as Parts 9 and 10 on Reference Plan 65R-6846.

Any owner of land in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.

(a) in the case of a registered owner, served personally or by registered mail, within thirty days after he is served with the notice, or when he is served by publication, within thirty days after the first publication of the notice;

(b) in the case of an owner who is not a registered owner, within thirty days after the first publication of the notice.

The approving authority is The Council of The Corporation of the Town of Whitchurch-Stouffville, 19 Civic Ave., Stouffville, Ontario.

NOTES:

1. The Expropriations Act provides that, (a) where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Minister of Justice and Attorney General; (b) The inquiry officer, (i) shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent, and (ii) may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.

2. "owner" and "registered owner" are defined in the Act as follows:

"owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested; "registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper registry, land titles or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment roll;

3. The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any other added as a party by the inquiry officer are parties to the inquiry.
