# Studies, flying combine in student's career plans

SANDFORD — An interest in flying has helped shaped the career plans of Sandford's Sonya Meek.

Although just 19, Sonya, a second-year Honors Geography student at the University of Waterloo, has already obtained her private pilot's licence.

"A lot of what I'm studying relates to flying," she says, noting that she'd like to eventually combine her chosen subject and her aerial hobby in a career.

Sonya, the daughter of Norman and Carol Meek, Sandford, is the recipient of the 1984 Ontario County Women's Institute scholarship for 4-H Homemaking Club members.

A \$200 cash award is going toward the cost of her university education.

Sonya completed 12 4-H units over a six-year period while earning County and Provincial honors. She also held offices of president, secretary and treasurer and was an assistant leader.

The Sandford youth group was another area of involvement and she also taught Sunday School for four years.

Despite her busy schedule, Sonya found time to help around the family farm, located on Conc. 4 south of Sandford.

Sonya's a graduate of Uxbridge Secondary School, where she was an Ontario Scholar and won the geography award in her final year.

Involvement with the year book, including 1982-83 when she served as editor, was an enjoyable high school experience.

Sonya, whose just about to turn 20, gained some valuable work experience this past summer while employed by the South Lake Simcoe Conservation Authority, Newmarket.

As a summer student involved with the Lake Simcoe Environmental Management Study, Sonya helped conduct a streambank erosion study.

She wrote a report documenting the findings, performed an agricultural field erosion identification study and updated computer files concerning water quality and quantity.

"It was a fun job and I really learned a lot," she says.

One of the reasons Sonya chose geography was the wide variety of subject matter that exists within the field.

She says her interest slants more toward the environmental and physical aspects of geography.

Her father, Norman, is a pilot and it was with him that Sonya got her first taste of flying.

"I love looking at the world from above."

### PUBLIC MEETING CONCERNING A PROPOSED OFFICIAL PLAN AMENDMENT

#### NOTICE OF MEETING

TAKE NOTICE that the Council of The Corporation of the Town of Whitchurch-Stouffville will hold a public meeting on Tuesday, December 18th, 1984 at 8:00 p.m. in the Council Chambers of the Municipal Building located at 19 Civic Avenue, Stouffville, Ontario to make available adequate information to the public regarding, and to consider, a proposed Official Plan Amendment to be passed pursuant to Section 17 of the Planning Act.

**SUBJECT PROPERTY**  
The subject property is the whole of the Town of Whitchurch-Stouffville, however the first community improvement area is designated as part of Lot 35, Concession 9 (formerly Township of Markham) and part of Lot 1, Concession 9. The easterly boundary is 91 Main Street East on the north side and Park Drive South on the south side; and the westerly boundary is Albert Street, as shown on the map below.


#### EXPLANATORY NOTE

The purpose of the proposed Amendment is to provide Community Improvement Policies for the Town of Whitchurch-Stouffville Planning Area; and to apply these policies as a first priority to the Stouffville core area, as shown on the map below.

If you are unable to attend, written submissions will be received up to the time of the meeting. Written submissions should include a request for further notification, if so desired.
