Thieves could be 'alarming'

Markham's Mike Harris says he can "insure" a worry-free vacation. He won't sell the life or medical type, but he'll ensure that the average home is well-enough equipped to prevent break-ins while the owners are off vacationing. Mr. Harris, 24, is the man behind the new Markham business called Securewatch. He employs hi-tech devices to temporarily protect homes against unwanted intruders.

"With the increase in unemployment you have an increase in crime," Mr. Harris told the Economist & Sun last week. "There definitely is a demand for protection."

He said his business is unique because it uses temporary electronic monitors that can easily be connected and removed. Two main components, a "passive infrared unit" (PIR) that detects body heat within a 60-foot diameter and a motion detector with a range similar to that of the PIR are used. Audible interior alarms are also connected to make would-be thieves think twice about sticking around.

"If one fails the other takes over," he explained. "It makes it next to impossible to break in without being detected."

Once the devices are connected, any movement is monitored from his Markham office on a 24-hour basis.

After a year of planning and research, he opened the company in June. Working for a home-protection service two summers ago while still in university gave him the idea to offer home-protection on a temporary basis.

"It's a unique concept but once the public gets used to it I think they'll agree its a good system," he said.

Customers are given a code that must be reported to the company over the phone in case a relative or neighbor accidentally triggers the alarm system. If the code isn't given, the police are called in.

"Most thieves know what they're doing. They do 'case the joint,'" he said. He also admits that he thinks his system is close to foolproof.

"You can ask a neighbor to watch your house while you're away," he noted. "But neighbors go to sleep at night and my system doesn't."

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described in Schedule "A", hereto. Any owner of land in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing,

- in the case of a registered owner, served personally or by registered mail, within thirty days after he is served with the notice, or, when he is served by publication, within thirty days after the first publication of the notice;
- in the case of an owner who is not a registered owner, within thirty days after the first publication of the notice.

- NOTES:
1. The Expropriations Act provides that,
 - Where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Minister of Justice and Attorney General;
 - The inquiry officer
 - shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent; and
 - may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.
 2. "owner" and "registered owner" are defined in the Act as follows: "owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or of a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested;
 - "registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper registry, land titles or sheriff's office; and includes a person shown as a tenant of land on the last revised assessment roll.
 3. The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry officer are parties to the inquiry.




