## Pulled knife on nurse

A 17-year-old youth, accused of threatening a York County Hospital nurse with a knife, was given a conditional discharge and placed on a two-year term of probation when he appeared in Newmarket Provincial Court.

According to evidence, Robert Sean Cooney had cut himself with a weapon before entering the hospital. When he was told to wait until a physician arrived, he pulled a knife on one of the nurses and said "get a doctor or you'll look like me!" Police were called.

Following a struggle, the youth was disarmed and arrested.

Counsel for the accused said his client had consumed a quantity of wine and pain-killers prior to the incident.

The judge, in passing sentence, described Cooney "as a mean man who picked on a helpless woman." He ordered the accused to refrain from drinking alcohol and not to possess or own any weapon.
