

Judge quashes charges

STOUFFVILLE — A charge of sexual assault against two Stouffville men and another from Scarborough was thrown out of court.

The three men, Elias Raptis and George Mantziouras of Stouffville and Nicholas Mantziouras of Scarborough, stood accused of sexually assaulting a 16-year-old girl who worked for them at the Country Stop Burgers restaurant.

They were in court June 3 to stand trial 16 months after the charge was laid.

Defence lawyer P. Murray asked that the charge be quashed on the grounds that it didn't make sense.

It alleges that the three men committed a single sexual assault on the girl between the months of October and December, 1984.

Provincial Court Judge Daryl Draper described the charge as absurd.

"No accused should be called upon to defend a charge that is manifestly absurd on its face," he said.

Crown attorney Elizabeth Cowie argued that the charge could be amended so the trial could begin. She requested that the wording of the charge be changed to: did sexually assault during the months of October, November and December, 1984.

Miss Cowie explained that by rewording the charge as such it made more sense but did not make the accused men any more or less guilty.

Mr. Murray disagreed saying that such an amendment would be changing not only the form (which can be 'amended') but the substance of the charge.

Judge Draper sided with Mr. Murray, saying: "The resulting charge would be so completely different as to deprive the accused of their legal rights."

"The new charge is complex. It may involve actions by one, two or three of the accused at different times, in concert or in various combinations," he said and with that he quashed the charge.

No new charge had been laid at press time.

Owner defends Sales Barn expansion plan

STOUFFVILLE — A proposed \$1.25 million redevelopment of the Stouffville Sales Barn will enhance its overall impact on the surrounding community, claims a co-owner of the well-known flea market.

Norm Faulkner defended the project, which would see the existing main barn structure adjoined by a similar structure to the east — after nearby subdivision residents claimed that expansion of the facility would further disrupt the neighborhood.

Several ratepayers voiced concerns including noise pollution and traffic congestion when the proposal came up for discussion at a Council public meeting June 3.

However, Mr. Faulkner, who owns the Hwy. 47 operation with Willowdale's Norm Clements, claimed there isn't going to be a doubling of the operation as many residents believe.

He said the purpose of a new barn is to accommodate vendors already selling their wares outdoors on the 36-acre property.

"Our demand for inside space is much greater than for outside space," Mr. Faulkner explained. "We don't expect to extend the market any more than it already is."

As to the post-expansion traffic situation, the Stouffville man said in an interview: "I think there will be some weekends when it will get heavier."

A prime concern of objectors is the inclusion of an 'amusement' designation in the requested commercial zoning bylaw.

While some feel this would leave the door wide open for the kind of attractions found at theme parks like Canada's Wonderland,

Mr. Faulkner stressed that kiddie car rides will be the barn's only form of amusement.

Health and traffic are the two main concerns, according to Council member Jim Sanders, who commended the proposal because of the owners' apparent attempt to improve the complex.

A new sewage system will be installed to meet regional standards and an additional 10 acres of parking will be created on-site to handle Saturday and Sunday crowds.

Several councillors spoke of the positive impact the facility has had in the area for decades, even referring to it as an "institution."

The majority of objectors reside at Westfield Estates, a prestige residential subdivision south-east of the Sales Barn.

Council is reserving a final decision on a zoning bylaw amendment, until it receives additional information from Town Planner Michael Saunders.

Mr. Faulkner said he hopes to begin construction this year.


Vehicle torched

Police lay additional charges

DURHAM REGION — An additional two people have been charged in the 1982 murder of Clark Major, 52, of Brooklin.

Mr. Major was dragged by a van and killed when he attempted to stop thieves from stealing his tires.

The two men arrested on June 3 are Donald Herbert McCoy, 36, of Midland Ave.; and Ralph Warren Fisher, 33, of Amroth Ave., both of Scarborough.

A third man, Danny A. Huntingdon of R.R. 1, Oshawa, has been charged as an accessory after the fact and with possession of stolen property.

McCoy and Fisher have been charged with second-degree murder, robbery, possession of stolen goods, and conspiracy to commit theft.

Previously charged in this case were Frederick Fisher of Whitby, his sister, Elizabeth Fisher, Oshawa; and a sister-in-law, Janet Fisher of Scarborough.

The arrests have come four years after the fact thanks to Durham Regional Crime Stoppers program, which aired a re-enactment of the crime on May 1.

Man killed in accident

UXBRIDGE TWP. — A 21-year-old Blackstock man was killed Friday when the southbound vehicle he was driving collided with an eastbound vehicle at Hwy. 47 and Durham Region Road 23.

Ontario Provincial Police said Garry Guernsey failed to obey a stop sign at the intersection and was struck by a vehicle driven by John Gorman of Bobcaygeon.


Guernsey died of injuries sustained in the crash.
