A \$3 million computer research and development centre is coming to Markham.

Minicom Data Corporation, a Toronto-based company that develops and produces microcomputer systems for real estate and building firms, recently announced that it will build the new facility on Renfrew Dr. in Markham.

Howard Honickman, president of Minicom, said the 27,000 square-foot, two-level building will initially house more than 100 staff members, 75 of whom are dedicated to client training and support and software development.




