STOUFFVILLE — A lovely white quilt is spread out on frames in the centre of the living room at Parkview Apartment 113.

The finished product will be auctioned at the Pioneer Village Mennonite Festival, Sept. 20.

"I have a quilt on the go all the time," says Elizabeth Hercher, "I'm kind of slow at it, but it keeps me out of mischief."

Mrs Hercher, a kindly lady with a warm smile, marked her 94th birthday, Aug. 21. The celebration took the form of a dinner party the preceding Saturday at Cullen Country Barn, Milliken. She was accompanied by Mr and Mrs Paul Winger and Beulah Jones.

Mrs Hercher, the former Elizabeth Winger, was born at Old Edgeley in the Twp. of Vaughan. At age seven, her parents moved to a farm property at Dufferin Street and the Carrville Road. Later, she and her husband lived in Richmond Hill. Mr Hercher passed away in 1977.

"I couldn't have a better place," Mrs Hercher says of her cozy apartment. Just outside her east-view window is a garden of beautiful flowers, also a feeder for the birds.

Although she spent three weeks last year in York Central Hospital, Richmond Hill, Mrs Hercher has made an excellent recovery.

A long-time member in the congregation of Heise Hill Church, (her father, Abraham Winger was a pastor there), Mrs Hercher attends services as often as possible. Walter Hill or Martha Wideman provide the transportation. "I usually go with one and come home with the other," she says with a smile.

In the centre of the living room table are dozens of cards, and bouquets of flowers.

"I know most of the people here," she says, naming many of the folk residing on the two floors. Almost every afternoon, Beulah Jones, a cousin, drops in for a chat. Elizabeth looks forward to her visits.

Mrs Hercher keeps her radio tuned to C.F.R.B. "Betty Kennedy was always one of my favorites," she says.

When I called to make an appointment, the receptionist at Parkview responded with: "Mrs Hercher, why yes, she's a wonderful lady."

NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND

IN THE MATTER OF an application by The Corporation of the Town of Markham for approval to expropriate land being part of Lot 11, Concession 4, Town of Markham, Regional Municipality of York, being Part 1, on draft plan of expropriation known as Job No. 86-233 for the purpose of sites for the establishment and carrying on of industries and of industrial operations and uses incidental thereto.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described as follows:

Any owner of lands in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.

NOTES:

- The Expropriations Act provides that, (a) where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Attorney General. (b) the inquiry officer, (i) shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent, and (ii) may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.
- "owner" and "registered owner" are defined in the Act as follows: "owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or of a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested; "registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper land registry or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment roll.
- The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry officer are parties to the inquiry.
