#### WHAT WAS SAID

In The Newmarket Era of November 26, 1986, Marshall Jarvis, President of the York Unit of Ontario English Catholic Teachers Association, was quoted as saying:

"Money is not the problem here, staffing is. The Board is not addressing staffing concerns and working conditions".

The newspaper article went on to state that:

"Jarvis blamed the failure of last week's mediation on the Board's unwillingness to reduce class size".

#### THE FACTS

1. Article 15.08 (d) of the collective agreement deals with the system-wide pupil/teacher ratio.

The York Region Roman Catholic Separate School Board has agreed to reduce the pupil/teacher ratio to the very number proposed by the Teachers' negotiating committee.

2. Article 15.08 (a) deals with the allocation of teaching staff to grades 1 to 8 based on a ratio of so many students to 1 teacher.

The Board has agreed to reduce this ratio to the very number proposed by the Teachers' negotiating committee.

3. Article 15.08 (b) deals with the allocation of teaching staff to junior and senior kindergarten based on a ratio of so many students to 1 teacher.

The Board has agreed to reduce this ratio to the very number proposed by the Teachers' negotiating committee.

4. Article 15.08 (c) deals with the allocation of teaching staff to the secondary schools based on a ratio of so many students to 1 teacher.

The Board has agreed to reduce this ratio to the very number proposed by the Teachers' negotiating committee.

5. The Board has proposed introducing into the collective agreement a new Article 15.08 (e) dealing with the maximum class sizes in junior and senior kindergartens, in grades 1 to 8 and in secondary schools.

The Board's negotiating committee has been led to believe that the numbers proposed in the said Article would be acceptable to the Teachers' negotiating committee.

- 6. In its submission to the fact finder, the Board indicated its preparedness to meet the substantial increases in staff proposed by the Teachers' negotiating committee under Articles 15.08 (a), (b), (c) and (d) but stated that it could not afford to simultaneously increase staff to that extent and grant the substantial increase in wages being sought by the Teachers.
- 7. The Board did not agree to the Teachers' final position on wage increases.

#### CONCLUSION

The Board has addressed staffing concerns and working conditions.

Staffing is not the problem here.
