\$3,000 in tools taken in theft

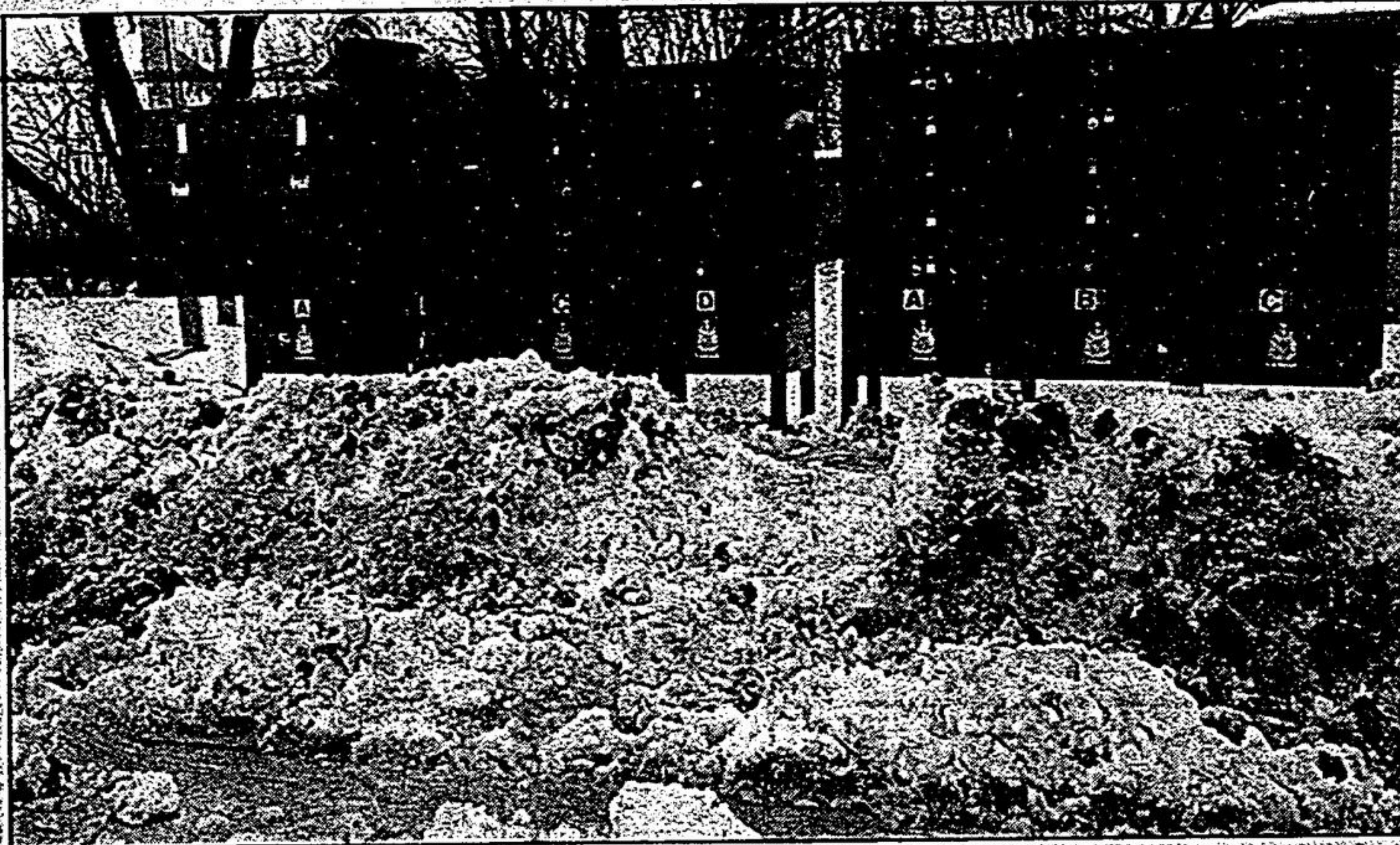
Around \$3,000 worth of tools were stolen from a Unionville man's tool shed on Sunday night.

Mailbox cleared: manager

Despite heavy snow in recent weeks, the manager of the Markham Post Office said he has received only one complaint of snow blocking the super mailboxes.

Station manager Walter D'souza said a resident called last Monday complaining the superboxes on Manhattan Crt. were blocked with snow.

Mr. D'souza said he immediately notified the company contracted to clear the snow and understood that crews had been sent out on Monday and Tuesday morning.

Pat Riley, who dispatches snow removal crews to the super mailboxes for the Ernie Wilkens Masonry company, explained crews often have to clear snow from in front of the boxes more than once during a snowfall.

Often city snowplows would come by and block the boxes with snow again, he said.

It appeared this was the case with the superboxes on Manhattan Crt. Snow was piled in front of the boxes but a path had been cut through the bank of snow.

Mr. Riley said the company doesn't dispatch snow removal crews until notified by the post office because they work under an open contract.

The post office, in turn, waits for letter carriers to report boxes are blocked.

The snow is supposed to be cleared from in front of the boxes within a 24-hour period.

Because the Post office's regular station manager Denny Chan has been away the last two weeks, Mr. Riley suggested there may have been a delay in the company being notified.

Getting the snow cleared from in front of the boxes "rests largely on person running the station," he said. "Maybe there was a lack of communication this time."

Mr. Riley said he'd like to see some communication set up between their company and the Town.

"If we knew when the Town planned to plow certain routes then maybe we could coincide our plowing with theirs," he said.
