## THE CORPORATION OF THE TOWN OF MARKHAM

### TAKE NOTICE THAT:

- The Council of the Corporation of the Town of Markham intends to construct as a local improvement sanitary sewers with man-holes and service connections on:
  - Kennedy Road from Helen Avenue to 115 metres northerly;
  - Helen Avenue — the entire length being 1,000 metres and intends to specially assess the construction upon the land abutting directly on the work.
- The estimated cost of the work is \$439,950.00. The estimated cost for the installation of the sewers per metre frontage is \$212.33. The special assessment is to be paid in twenty (20) equal annual instalments and the estimated annual rate per metre frontage is \$26.66 per metre. The cost of each house service connection is \$900.00. The special assessment for the house service connection is to be paid in twenty (20) equal instalments and the estimated annual rate per connection is \$113.02.
- The following is an example of the annual charge for a home having a thirty metre frontage:
 

30 metres at \$26.66 per metre:	\$799.80
Cost for one house connection at an annual cost of \$113.02:	113.02
Total annual cost over 20 years for above:	\$912.82
Annual sewer service rate in addition to the above:	65.00
<b>TOTAL ANNUAL COST:</b>	<b>\$977.82</b>

 Optional cash payment in advance for the above, per metre, including house service connections: \$7,269.900  
 Annual sewer service rate in addition to the above: \$65.00  
 Any ratepayer may, within twenty-one (21) days after publication or mailing of this notice, whichever is later, serve personally or by registered mail on the Clerk of the Town of Markham, at the address given below, a notice in writing stating his/her objection to the imposition of the special rate, and that if a public hearing is held, he/she or his/her representative will attend such hearing to support such objection.
- The Ontario Municipal Board may approve the said special rate pursuant to the statute, but before doing so it may appoint a time and place for a public hearing when any objections will be considered; but notice of such hearing will be given only to those persons who have given notice of objection as provided for above.

TAKE NOTICE THAT the Council of the Town of Markham intends to pass a by-law pursuant to Section 210, Subsection 141 of The Municipal Act, R.S.O. 1980, as amended, to amend By-law Number 344-86, regulating signs and other advertising devices in the Town of Markham.

The purpose of the proposed by-law is to amend Section 13 of By-law 344-86 respecting "Standard Non-Accessory Signs (Billboards)" with respect to the erection of standard non-accessory signs on vacant land zoned by by-law as commercial or industrial, and railway and hydro lands which are not adjacent to residential areas, and to restrict the number of standard non-accessory signs within the Town of Markham to ten (10).

A copy of the proposed by-law to amend By-law 344-86 is available for inspection in the Clerk's Department of the Municipal Building at 8911 Woodbine Avenue, Buttonville, Ontario between the hours of 8:30 a.m. and 4:30 p.m., Monday to Friday.

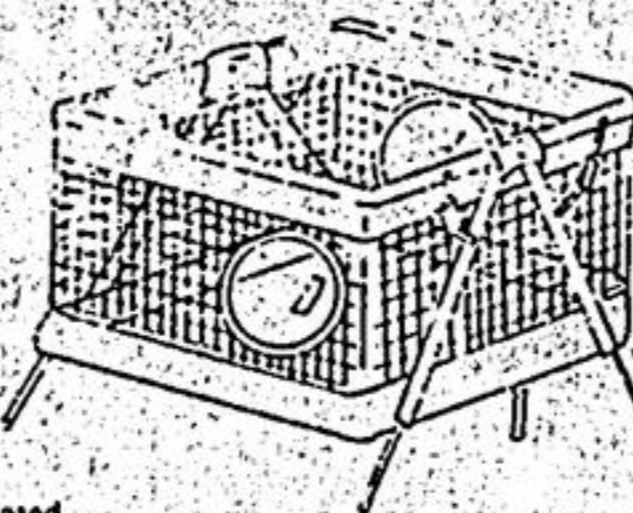
