### NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the Town of Markham on the 15th day of December, 1987 passed a motion of intention to designate the property, including lands and buildings, known municipally as Part of Lot 30, Concession 4, south east corner of Woodbine Avenue and 19th Avenue, of architectural and/or historic interest or value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

### Short Statement of the Reasons for the Proposed Designation:

The Richard Lewis House c. 1850 located on Lot 30, Concession 4 is recommended for designation for architectural significance, as a fine example of a brick Ontario Cottage with Regency and Classical Revival Influence and for historical significance with the Lewis and Francey families who were closely associated with the development of the hamlet of Gormley.

ANY PERSON MAY, within thirty (30) days of the first publication of this Notice, send by registered mail or deliver to the Clerk of the Town of Markham, notice of his or her objection and all relevant facts. If such Notice of Objection is received, the Council of the Corporation of the Town of Markham shall refer that matter to the Conservation Review Board for a Hearing.
