Business Improvement Area board Decision Day nears

It's decision time for Business Improvement Area merchants. Downtown business people must decide by next month if they're willing to commit \$100,000 over the next ten years for the beautification of Stouffville's downtown core.

At a public meeting Feb. 18, held at the Recreation Centre, Mayor Fran Sainsbury told the audience of about 15 merchants they must respond quickly with their proposal to the Ontario Ministry of Municipal Affairs.

Presently, the Ministry has offered a PRIDE grant of \$280,000 on the condition the Town's Community Improvement Plan is approved by all groups involved in financing the \$680,000 project.

Mayor Sainsbury said if the plan isn't submitted by next month they'll lose the opportunity to beautify a section of Main from Albert Street to Park Drive.

The issue of refurbishing Main Street was initially discussed about one year ago. At that time the Community Improvement Committee, with the support of the BIA and the Stouffville Hydro-Electric Commission were one of the 1,742 applicants vying for about 70 PRIDE grants.

In addition to the Ministry's grant, under the present scheme Hydro will pay \$100,000 over the next four years; the BIA will spend \$100,000 and taxation and lot fees will cover the balance.

Ged Stonehouse, a former BIA member voiced concern. While

supportive of the idea, Mr. Stonehouse questioned the BIA's procedure in informing its 85 members. He wondered at the BIA's financial commitment of \$100,000 for 10 years noting that when the proposal was put forward at a meeting a year ago, the board recommended it be discussed with the membership before a commitment was made.

If provincially approved, signage, decorative lighting, and sidewalk-curb repair would begin on Main Street in early summer and be completed by early autumn, according to Hydro chairman Herb Peach.

Business Improvement Area members will likely decide their course of action at the March 2 General Meeting in the Public Library.
