

Fishing licence has its good points too

While the Ontario resident sport fishing licence is viewed as an inconvenient government tax by some people, there is no doubt its introduction a year ago has given our fresh water fishery a much needed boost.

In the past the yearly costs of the Ministry of Natural Resources' fishing programs were

part of this province's annual budget.

As such, any allotment to sport fishing was dependent not only on priorities within their ministry, but on any number of demands in the many other branches of the provincial government.

Thus if it was a particularly hazardous fire year, a large portion of the Natural Resources' budget was used to finance the extra costs involved in fighting fires.

Consequently other programs and plans such as fish studies, expanded stocking, spawning rehabilitation, and law enforcement were scaled down accordingly.

Similarly the outbreak of forest

pests such as the recent Gypsy Moth plague dictated the Ministry's priorities in that regard.

The all-time high water levels recorded in 1986 on the Great Lakes is another example of how the provincial pie was cut.

This emergency situation necessitated nearly \$2 million in MNR funds to be allocated for flood and erosion control including the issuance of a million bags of sand to help protect residential property.

Locked into an Ontario budget that included even highway construction expenditures the Ministry of Natural Resources was open for mounting criticism.

Yet while MNR's Fisheries

Branch was hard at it trying to come up with solutions to maintain the sport fishery in some areas, the problems were being compounded in other ways.

Deteriorating water quality, added fishing pressure, acid rain, and the loss of nursery habitat due to shoreline development on many waterways were very real factors.

They affected not only fresh water fish productivity but the management of the resources as well.

Relying on past studies, background information, and public input, each MNR District in Ontario is now preparing a detailed Fisheries Management Plan.

The identification of the long-term fisheries' goals and the short term actions needed to achieve the desired results will be used as a fisheries directive until the year 2000.

In addition the MNR has an ongoing program of assessment of fish populations and spent \$5.1-million on new fish culture facilities in 1986-7.

An additional \$450,000 for Community Fishery Involvement Projects was also allotted by the ministry during the same period.

It's quite possible these projects and others, including putting additional law enforcement officers in the field, would have come about at some point in time, even without the resident fishing licence.

However I believe that by laying our 10 bucks on the line, we are staking our rightful claim not only as participants but also stewards of this magnificent past-time called fishing. Our annual vested interest is a constant monitor to a sport that can only get better.
