Town citizens' fund to favored causes

Dear Editor:

As, no doubt, the majority of Tribune readers will recall, the Concerned Citizens of Whitchurch-Stouffville was formed in 1981 to lobby against the proposed expansion of the York Sanitation Landfill Site on Hwy. 48.

The objectives of the group subsequently expanded to persuading the Ministry of the Environment to close the site permanently and take all possible precautions aimed at ensuring the purity of local water supplies. We also argued forcefully in favor of a detailed health study of Whitchurch-Stouffville residents.

It finally appears that our task is almost over. The site is officially closed, monitoring is ongoing; those most at risk have received alternate water supplies and representatives of the Concerned Citizens played an active role in the Ministry of Health study of local residents.

Consequently, the group has addressed the situation of surplus funds that are being held in our bank account.

A considerable sum of money was raised, donated and spent during the course of our activities. I have attached a summarized statement of receipts and expensed that we would be

happy for you to publish if you so desire. The surplus of \$7,166 has been held until now in case it was needed to ensure promises made to our Town were kept. Given the nature of the fund-raising, it is impractical to try and return money to its original source on a pro-rata basis.

Accordingly, the executive of the Concerned Citizens has elected to donate the funds as follows:

(1) Five hundred dollars to each of the local schools: S.D.S.S., Summitview, Orchard Park, St. Mark's, Whitchurch-Highlands and Ballantrae; to purchase books on environmental studies for their libraries. Our children are our future.

(2) Five hundred dollars to the Markham Branch of Save The Rouge Valley. We believe this to be the most significant current environmental issue and one that is likely to impact on this whole area.

(3) Three thousand, two hundred and fifty dollars to the Markham-Stouffville Hospital. The benefit this hospital will bring to residents of our town is obvious to all.

The balance of \$416 will be held to keep the group's account open in case we should need to raise funds in the future, and to allow us to continue liaison with other

citizens groups across the Province.

Whitchurch-Stouffville is the definitive case study on how to fight City Hall; (in this case Queen's Park) and win.

Much was made of the supposedly adverse publicity during the early 1980s, but the genuine respect held for our community by local citizens groups all over Canada is much longer lasting.

We have tried to dispose of our surplus funds in a manner reflecting the objectives under which they were raised. I hope the majority of the many people who supported us financially will find our decisions acceptable.

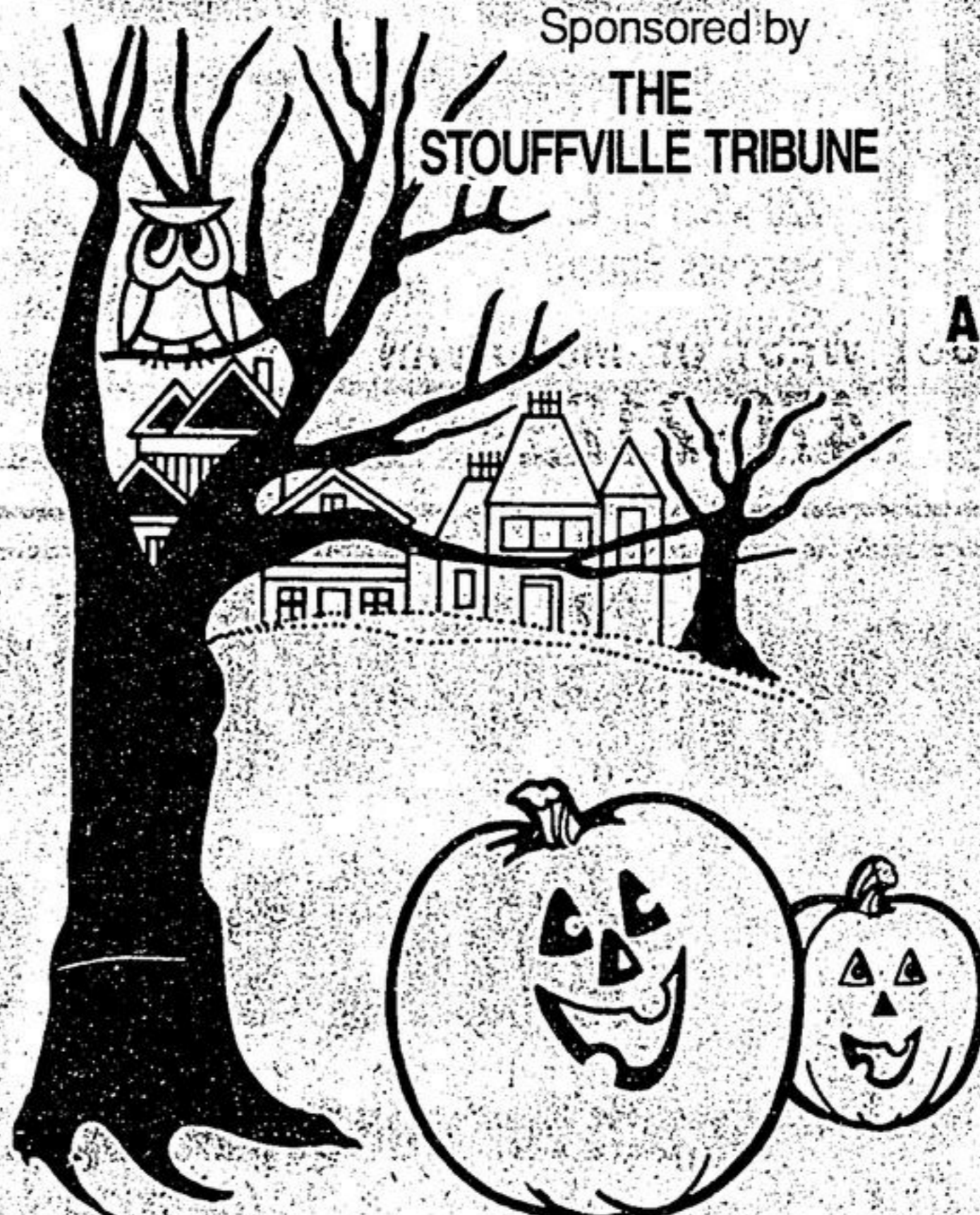
