 - And she confesses, "I started to giggle to cover up my feelings


just like I did when I was a young girl."

QUALIFICATIONS OF AN ELECTOR

RESIDENT

During the period from September 6, 1988 to October 17, 1988

- a) is a resident in the municipality
- b) is a Canadian Citizen; and
- c) has attained the age of eighteen years, or on or before Polling Day will attain the age of eighteen years.

NON-RESIDENT

During the period from September 6, 1988 to October 17, 1988

- a) is the owner or tenant of land in the municipality or the spouse of such owner or tenant;
- b) is a Canadian Citizen; and
- c) has attained the age of eighteen years on or before Polling Day will attain the age of eighteen years.

Persons not eligible to be entered on the revised List of Electors but since the period of revision have become a Canadian Citizen, may apply to the Clerk for a certificate to vote on Polling Day.

AN ELECTOR IS ENTITLED TO VOTE:

- i) if resident in the municipality, in the polling subdivision in which he RESIDES; or
- ii) if not resident in the municipality, in the polling subdivision in which his name appears on the polling list

OFFENCES, PENALTIES AND ENFORCEMENT

Every person who, at an election,

- (a) not being qualified to vote, votes;
- (b) being qualified to vote, votes more times than he is authorized to vote by this Act; or
- (c) votes in a polling subdivision other than one in which he is entitled to vote by this Act;

is guilty of a corrupt practice and is liable to a fine of not more than \$2,000, or to imprisonment for a term of not more than six months, or to both.
