The Menger Gallery is located on Union Street, Gormley, west of Woodbine Avenue on the Stouffville Road. The building is the former Gormley Post Office.



## Need for housing a 'concern'

Dear Jim:

I wish to respond to a letter published in your Nov. 2 issue above the name of Mrs. Bruce Davis.

We are grateful to Mrs. Davis for her very kind words about Parkview Village. In her letter she asks:

"If the Government can subsidize Parkview Village for Seniors, why can't the same kind of accommodation be provided folks at the other end of the scale?" Mrs. Davis also draws attention to the serious lack of affordable housing for newlyweds and single parents.

Her questions are valid. They express a concern many of us feel keenly about — the urgent need for adequate housing at reasonable cost in this high-cost area surrounding Metro Toronto.

I wish to comment as follows:

(1) We are able to build and operate rental housing at Parkview Village, 70 Ninth Line South, because of generous financial assistance from both the Federal and Provincial governments as follows:

(a) The capital funding assistance for building construction was provided under Section 6, subsection 56.1 of N.H.A.

(b) The federal government also provides ongoing subsidies that are applied to the mortgage interest, which significantly reduce the rents to all Tenants.

(c) In addition, ongoing subsidies to reduce rent to eligible persons is provided by the Ontario Government under the Ontario Community Housing Assistance Program.

This funding is available only to non-profit agencies.

(2) The point I wish to make is that similar financial assistance for both capital costs and rental assistance is indeed available to housing for families and special groups such as single parents but only to non-profit groups.

At the present time, the Non-Profit Housing Program of the Ontario Ministry of Housing is the vehicle used to provide both Federal and Provincial assistance.

(3) Non-profit housing co-operatives can also be formed and can become eligible given the appropriate conditions.

(4) In our Town, the present problems, as everyone knows, is a lack of sewage disposal facilities. When and if the Council, in co-operation with the Region, is able to solve this problem, non-profit programs, as I've described, could be the vehicle to provide very reasonably priced rental housing to persons in other age categories than the Seniors who are served by Parkview.
