The church is hoping to offer one or two such programs every year on different reserves.

INVITATION TO COMMENT DRAFT RURAL AREA POLICY INCLUDING LOCATIONAL CRITERIA FOR GOLF COURSES

At the request of Pickering Town Council, Planning staff has prepared Planning Report No. 7/90 addressing locational criteria for golf courses.

During the review, staff concluded that golf course policies should be developed in the context of an overall rural area policy. Thus, the draft policy includes general rural area policies plus specific golf course policies.

On June 25, 1990, Town Council received Planning Report No. 7/90 and requested that it be circulated to the community for comment and further input.

PUBLIC MEETING CONCERNING A PROPOSED ZONING BY-LAW AMENDMENT ACCESSORY COMMERCIAL USES (M1 & IL ZONES) FILE NO. ZBA90.025

NOTICE OF MEETING

TAKE NOTICE that the Council of The Corporation of the Town of Whitchurch-Stouffville will hold a public meeting on **TUESDAY, SEPTEMBER 4th, 1990, at 8:10 P.M.** in the Council Chambers of the Municipal Building located at 19 Civic Avenue, Stouffville, Ontario to make available adequate information to the public regarding, and to consider, a proposed Zoning By-law Amendment to be passed pursuant to Section 34 of the Planning Act.

SUBJECT PROPERTY

The subject property comprises those lands zoned Industrial Restricted (M1) on SANDFORD DRIVE (PLAN 65M-2572 INCLUDING CONDOMINIUM PLAN NO. 629) and those lands zoned Industrial Light (IL) on RINGWOOD DRIVE (PLAN 65M-2674).

EXPLANATORY NOTE

Industrial Restricted (M1) and Industrial Light (IL) Zones in Zoning By-law No. 72-7 permit "accessory/incidental commercial uses". The proposed Amendment will modify the M1 and IL Zone Requirements to provide that a maximum of 25 percent of the gross floor area may be used for accessory/incidental commercial uses. This restriction will not only apply to the total building(s) for a single user, but also to individual rental or condominium units. Parking must be provided in accordance with the parking requirements based on the floor areas devoted to commercial, industrial, office or their specified uses.

An existing use which presently exceeds the 25 percent limitation is permitted to continue as it exists provided that such use has been legally established.

REPRESENTATION

ANY PERSON may attend the public meeting and make written or oral representation either in support of or in opposition to the proposed Zoning By-law Amendment. If you are unable to attend, written submissions will be received up to the time of the meeting. Written submissions should include a request for further notification, if so desired.
