



EXPROPRIATIONS ACT

Notice of Application for Approval to Expropriate Land

IN THE MATTER of an application by The Regional Municipality of York for approval to expropriate the land described in Schedule "A" hereto, in the Town of Whitchurch-Stouffville in The Regional Municipality of York, geographically in the Township of Whitchurch in the County of York, for the purpose of:

- the widening of Bloomington Road (YR 40) from approximately 275 metres west of McCowan Road (YR 67) to approximately 300 metres east of McCowan Road (YR 67), in the Town of Whitchurch-Stouffville, to a basic width of 36.0 metres, with additional widenings at cuts, fills and the intersection at McCowan Road (YR 67) to provide two through lanes and additional left and right turn lanes in each direction at the intersection; and
- the widening of McCowan Road (YR 67)/7th Concession Road from approximately 200 metres south of Bloomington Road (YR 40) to approximately 200 metres north of Bloomington Road (YR 40), in the Town of Whitchurch-Stouffville, to a basic width of 36.0 metres with additional widenings at cuts, fills and the intersection at Bloomington Road (YR 40) to provide one through lane and an additional left turn lane and a right turn taper in each direction at the intersection.

NOTICE IS HEREBY GIVEN that application has been made for approval to expropriate the land described in Schedule "A" hereto. Any owner of lands in respect of which notice is given who desires an inquiry into whether the taking of such land is fair, sound and reasonably necessary in the achievement of the objectives of the expropriating authority shall so notify the approving authority in writing.

- in the case of a registered owner, served personally or by registered mail within thirty days after he is served with the notice, or, when he is served by publication, within thirty days after the first publication of the notice;
- in the case of an owner who is not a registered owner, within thirty days after the first publication of the notice.

NOTES:

- The Expropriations Act provides that:
 - where an inquiry is requested, it shall be conducted by an inquiry officer appointed by the Attorney General.
 - the inquiry officer:
 - shall give every party to the inquiry an opportunity to present evidence and argument and to examine and cross-examine witnesses, either personally or by his counsel or agent, and
 - may recommend to the approving authority that a party to the inquiry be paid a fixed amount for his costs of the inquiry not to exceed \$200 and the approving authority may in its discretion order the expropriating authority to pay such costs forthwith.
- "owner" and "registered owner" are defined in the Act as follows:

"owner" includes a mortgagee, tenant, execution creditor, a person entitled to a limited estate or interest in land, a committee of the estate of a mentally incompetent person or of a person incapable of managing his affairs, and a guardian, executor, administrator or trustee in whom land is vested;

"registered owner" means an owner of land whose interest in the land is defined and whose name is specified in an instrument in the proper land registry or sheriff's office, and includes a person shown as a tenant of land on the last revised assessment role.
- The expropriating authority, each owner who notifies the approving authority that he desires a hearing in respect of the lands intended to be expropriated and any owner added as a party by the inquiry officer are parties to the inquiry.

JK starts staggered

Half the junior Kindergarten classes slated for Stouffville schools won't start until the final year of a four-year phase-in plan.

The start-up dates for the primary grade will be staggered over four years. This September, the first two classes of JK will start at Ballantrae Public School. Only children living inside the Ballantrae P.S. boundary can be enrolled. Two more classes will start at Orchard Park P.S. in 1996 while Summitview P.S. and Whitchurch Highlands P.S. will each offer two classes in the fall of 1997.

The board estimates the initial 24 classes starting this fall across the region will house 480 of the eligible 4,300 children aged three and four years old. According to a board report passed Monday, the remaining 196 classes will be phased in over the following three years at a total cost of \$36,609,000.
