### ONTARIO COURT OF JUSTICE

#### (General Division)

### NOTICE TO NEW HOME BUILDERS, OWNERS AND PURCHASERS IN YORK REGION

The Municipalities of Vaughan, Markham, Richmond Hill, Newmarket, Aurora and Georgina have applied to the Ontario Court (General Division) to determine a number of questions arising under Part III of the Development Charges Act, R.S.O. 1990, c.D.9 (the "Act") relating to education development charges that municipalities in York Region did not collect on behalf of the York Region Board of Education and York Region Roman Catholic Separate School Board between on or about June 14, 1993 and February 9, 1994.

By order of the Honourable Mr. Justice Campbell dated July 5, 1994, the Court directed that notice of this application be published in newspapers of sufficient general circulation in the area of the jurisdiction of the School Boards to give potentially affected persons notice of the application.

The questions which the Court will be asked to answer are as follows:

1. Are the education development charges (the "Charges") established by by-laws dated November 18, 1991 by the York Region Board of Education and the York Region Roman Catholic Separate School Board (the "School Boards") due and payable in respect of properties for which building permits were issued between June 14, 1993 and February 9, 1994 where the charges were not collected by the applicants on behalf of the School Boards as a result of the Divisional Court's decision quashing the by-laws and the Court of Appeal's refusal to stay the decision?
2. In the event that the uncollected Charges are held to be due and payable in answer to question 1 above:
  - (a) At what date did the uncollected Charges become due and payable?
  - (b) Apart from private contractual arrangements, are the uncollected Charges under the Act and School Board by-laws due and payable from the current owner, the owner at the time the building permit was issued, the permit applicant or some combination of these persons?
  - (c) Are the municipalities legally obliged by the Act or otherwise to add the amounts of the uncollected Charges to their tax rolls pursuant to section 39 of the Act, and if so, when?
  - (d) Where the municipalities have prepared a certified statement of arrears due pursuant to section 415 of the Municipal Act, without reference to the uncollected Charges, can the municipalities add the uncollected Charges to the tax rolls?
  - (e) If the amounts of the uncollected Charges are added to the tax rolls, what obligation, if any, do the municipalities have to collect those Charges, in what manner, and at whose expense?
  - (f) Are any amounts owing with respect to interest for late payment of the uncollected Charges, and if so, to whom and from what date?
  - (g) If the uncollected Charges are added to tax rolls on which there are other arrears of taxes, and payment on account of the Charges is received, how is section 412 of the Municipal Act to be applied if at all, and against what arrears is such payment to be applied?

The application will be heard at 10:00 a.m. on September 19 and 21, 1994, at the Court House, 361 University Avenue or just to the south at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.

Persons who applied for and received building permits in York Region between on or about June 14, 1993 and February 9, 1994 and who did not pay education development charges, and prior or current owners or purchasers of new homes or buildings in York Region, in respect of which education development charges were not collected by the municipalities between on or about June 14, 1993 and February 9, 1994, may be affected by the outcome of the Court proceeding.

These persons may wish to obtain legal advice. It is recommended that they contact their own lawyer, or they may call the Lawyer Referral Service of the Law Society of Upper Canada, at (416) 947-3330 for assistance.

Copies of the court documents may be viewed at the Municipal offices in Vaughan, Markham, Richmond Hill, Newmarket, Aurora, and Georgina during regular office hours.

Interested persons or their lawyers who wish to participate in the court proceeding and to make submissions to the Court should indicate their intent to participate in writing, to Weir & Foulds, Suite 1600, Exchange Tower, 2 First Canadian Place, Toronto, Ontario M5X 1J5, attention J.G.
