10 foot by 10 foot fire. Also, the York Regional Police responded, council was told.

"The area of the fire posed no threat. The fire was clearly under control. A tractor located in the barn could have put out the fire in five minutes," said Kuettel.

Kuettel said he told the fire fighters that they were neither needed nor wanted. The fire fighters, in turn, told Kuettel they were under orders to extinguish the fire. Since Kuettel did not have a burning permit, the fire fighters put out the fire. Because the fire was in Stouffville, Aurora billed Stouffville for costs. Since Kuettel set the fire, Stouffville administration suggested he reimburse them. Kuettel refused. The issue resulted in a series of phone calls and meetings between the fire chief, Whitchurch-Stouffville chief administrative officer Merlin Dewing and Kuettel.

For the next three years, Kuettel got the free burning permits from the municipality of Aurora. However, in 1994, he was denied a burning permit and the issue found its way back to Stouffville where council was asked to intervene. Council was told too much time has lapsed for the municipality to initiate legal action against Kuettel.

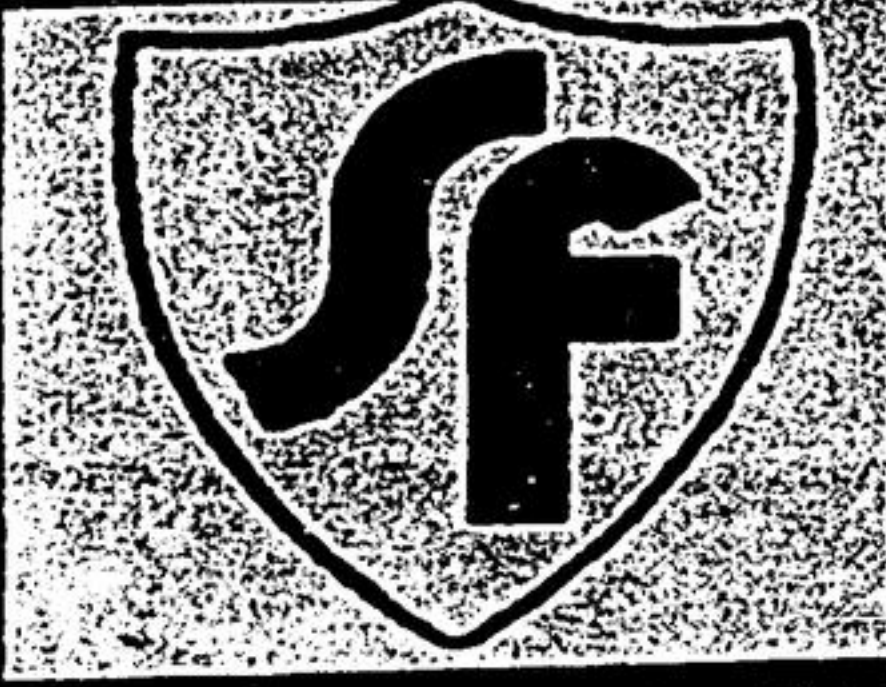
