**New rules make deducting child care expenses easier**

Going back to school? Whether you are going back to finish high school or to obtain a degree, recent changes to the child care expense deduction rules make it easier for you to deduct child care expenses.

This will also apply if you are married and both you and your spouse are full-time students. As well, for the first time, parents who complete high school are allowed this deduction. The age limit for the

children. It is especially helpful for parents who travel on business and need someone to supervise their teenagers.

For the first time, parents who complete high school are also allowed to claim child care expenses against any kind of income.

If you're a single parent who goes to school full-time, you will be able to claim child care expenses against any kind of income, not just against employment income.

Even if parents do not end up incurring child care expenses for their 15- or 16-year-olds, raising of the limit may increase the total amount deductible for other children.

If you have children ages eight, 10 and 15, your child care limit under the old rules was \$6,000 (\$3,000 per eligible child). Under the new rules it will be \$9,000, since there are three eligible children instead of only two. It does not matter for which children the expenses are a ct u a l l y incurred.

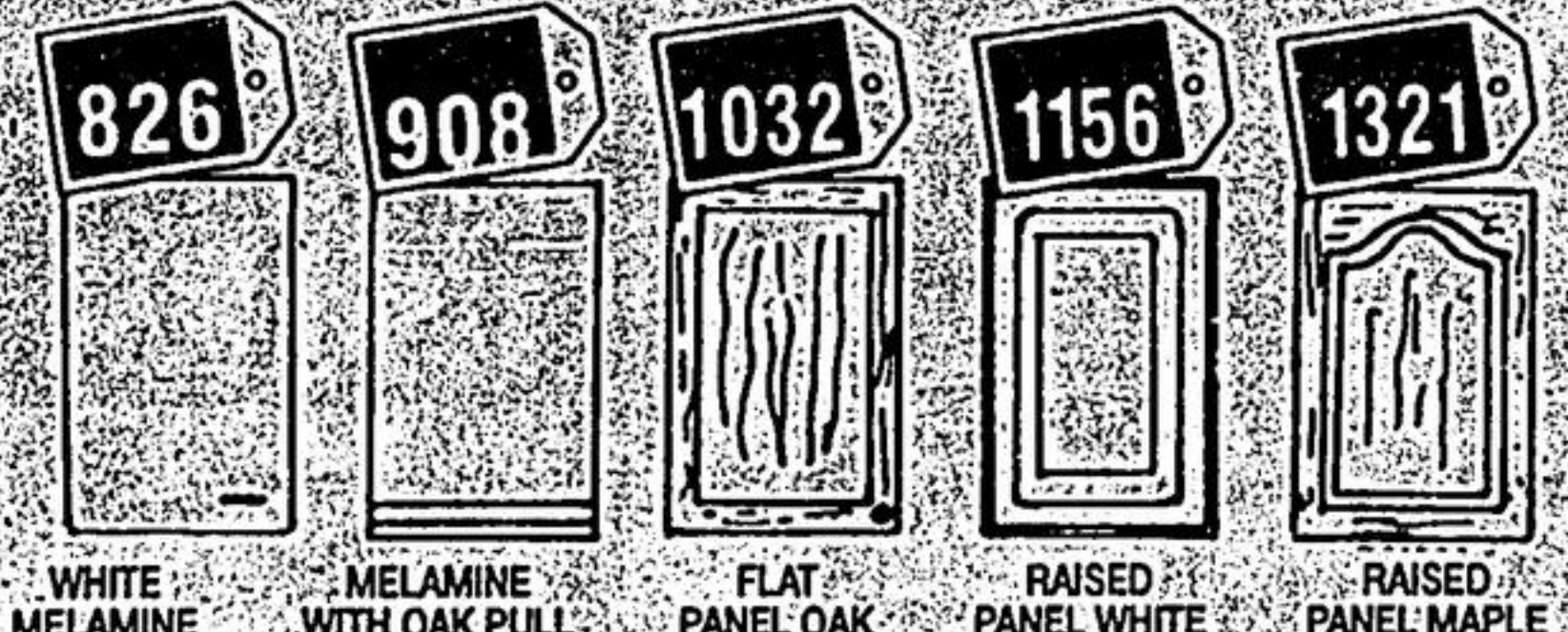
