Small financial losses can add up

The time to take chances, they say, is when you're young - because you've got 20 or 30 years to make up for any losses you may suffer.

True, as far as it goes, but losses - even relatively small ones - can have considerable consequences during a 25-year period.

A 25-year-old who loses \$3,000 on penny mining stocks can certainly come up with another \$3,000 in a year or two.

But what about the \$3,000 that was lost. Had it been invested in an equity-based mutual fund, that \$3,000 -

year - would be worth \$40,756 in 25 years.

If the fund returns 13 per cent a year, the \$3,000 would grow to \$63,692 and at 15 per cent a staggering \$98,757.

So, if you're spending \$10 to \$20 a week on lottery tickets, know precisely what it's costing you - especially if you're buying them year after year.
