

Home invasion suspect back in court today

A Downsview man facing criminal charges in connection with a home invasion and the kidnapping of a Gormley store owner was to make his third court appearance today.

While Sohaib Syed Razvi, 20, was to appear in the Newmarket court May 15, York Regional Police continue to seek two more suspects in connection with the crime.

Razvi, released on bail on a \$15,000 assurity, was charged with robbery, disguise with intent and forcible confinement.

On Feb. 12, the owner of Gormley's MIS Variety, was approached in the parking lot after closing his store.

York Region Sgt. John Sheldon reported that the store owner was forced into the vehicle at gun point and driven to his home on Bayview Ave. in the Elgin Mills area about 15 minutes from the store.

Once at the home, two of the suspects entered the house, confronted the

man's wife, showed her the gun, and her husband's drivers licence and threatened to kill him if she didn't cooperate. Sheldon said the woman, fearing for her life,

handed over \$5,000 in cash. She was handcuffed to the refrigerator, the telephone lines were cut and the master bedroom ransacked.

COURTS

The suspects fled in a getaway vehicle.
