

## Neighbors all shook up over Elvis concert

Is Elvis Presley breaking the law in Stouffville today?

The weekend salute to the King has raised the ire of two residents who live by the Stouffville Country Market.

Jamie Simm of Aintree Dr. and Peter Guinane of Cam Fella Blvd. are asking town administrator Merlin Dewing to take issue with the two-day event, tagged Memories of Elvis.

Dewing failed to return calls placed by *The Tribune*.

The karaoke-style musical attraction, which runs from noon until 4 p.m. on Saturday and Sunday, honors Presley, who died 20 years ago this weekend.

By hosting Memories of Elvis, market owner Norm Clements is violating a town bylaw, charge Simm and Guinane.

Clements disputed the claim.

"As far as I know, we're not violat-

ing any laws," he said. Mayor Wayne Emmerson said the big question is: Is a karaoke a concert?

Concerts are "prohibited on the subject lands," said Emmerson. "What has to be decided is, is this a concert or not."

Last week, a municipal bylaw officer informed Clements that he was about to get a summons linked to a musical event held two weeks ago.

"I'm picking up the summons this afternoon (Friday)," said Clements.

Simm has long charged that Country Market events attract noise, garbage, traffic congestion, lighting problems and undesirable people.

As a business owner, Clements said he's getting exasperated trying to satisfy the demands of "two" residents.

"There's 20,000 people in this town," he said.
