New campaign fights preventable blindness

One out of every two blind people in the world could be cured through eye surgery, which is why the Christian Blind Mission International (CBMI) has intensified its fight against cataract blindness.

Christian Blind Mission International in Stouffville has scored an important blow against the world's leading cause of blindness.

As an international force, CBMI and its partner hospitals in Asia, Africa and Latin America, have performed more than three million cataract operations since the organization launched its medical eye work back in the mid-'60s. This result places

CBMI at the forefront of national and international development organizations fighting worldwide blindness.

Over the past years, CBMI has been able to steadily increase the number of cataract operations performed each year at its supported hospitals: from 67,000 in 1980 and 148,000 in 1990, to a new record in 1996 — 268,000 cataract surgeries.

According to the World Health Organization (WHO), there are 40 million blind individuals worldwide, half of whom are blind due to cataracts.

Despite all the efforts of CBMI and other blindness-oriented organizations, the number continues to increase: each year it goes up by approximately one million.

In order to turn the tide against global blindness, CBMI is helping launch a new campaign, supported by WHO, for the "total elimination of avoidable blindness."

In the course of this campaign, with the help of friends in the Markham area, CBMI intends to have performed its four millionth cataract operation by the new millennium.

York-Durham Trunk Sewer System Master Plan Environmental Assessment Study INVITATION FOR PUBLIC REVIEW AND COMMENT

The Regional Municipality of York has completed a Master Plan for the York-Durham Trunk Sewer System (YDSS). The Master Plan identifies and reviews sewage servicing alternatives necessary to meet current and future growth and identifies an environmentally responsible, cost-effective approach to servicing future needs in York Region. A public information centre was held on April 24, 1997 to explain the project and solicit comments. The preferred design solution (see map below) consists of a series of individual projects which together constitute future improvements to the YDSS. The proposed works provide the needed capacity to manage the quantities of sewage generated in the Region from the future service area to the year 2031 including, potentially, the additional communities of Holland Landing, King City, Stouffville, Queensville and Nobleton. Priority projects which need to be implemented in the near future include:

- Aurora Pumping Station and Forcemain
- Humber Pumping Station and Forcemain to Peel
- Maple Collector
- 404 Trunk Sewer and Interim By-pass

Each component project of the Master Plan is distinguished based on its location, type of project, potential phasing and function. Dependent on project characteristics, route/site selection, preliminary design and additional public consultation will be undertaken. At this time, the Master Plan report documenting the Class EA process undertaken and conclusions reached is on display at the following locations for forty-five (45) calendar days beginning on August 12, 1997 and ending on September 26, 1997.

Subject to the satisfactory resolution of any concerns, implementation of specific projects will proceed as documented and scheduled in the Master Plan document. Opportunities to request that specific projects recommended in the Master Plan be bumped-up to a higher level of environmental assessment study will be allowed as part of the project specific Class Environmental Assessments.
