founded the mayor's youth committee and raised \$30,000 to help the town's young people. "During the next three years,

my goals will be to not increase taxes, and to maintain a cohesive relationship at the Region of York as well as a good working relationship with all of

council," said Emmerson. Watson said with Emmerson as mayor, it took four months for a report outlining deficiencies at the town hall to reach

council. "No one noticed or spoke up that there were no fire alarms, no fire extinguishers and no fire drills," said Watson.

"The building did not meet fire or building codes and yet no one said or did anything. The present mayor has not taken any disciplinary action at all in this matter. Why? It makes me wonder if we just try to justify building a new town hall by letting our old one fall below standards. We need a leader who will not allow our town to be negligent about serious deficiencies such as this," said Watson.

He also questioned the way tenders have been handled under the Emmerson administration.

"As mayor, one needs to be more responsible with Whitchurch-Stouffville's money," said Watson. "Policy dictates we tender all contracts over \$25,000. However, council waives this tender policy at their leisure."

In encouraging people to vote on Nov. 10, Emmerson reminded everyone that a municipal vote is a "very important" vote.

"It affects your lifestyle the most," said Emmerson.

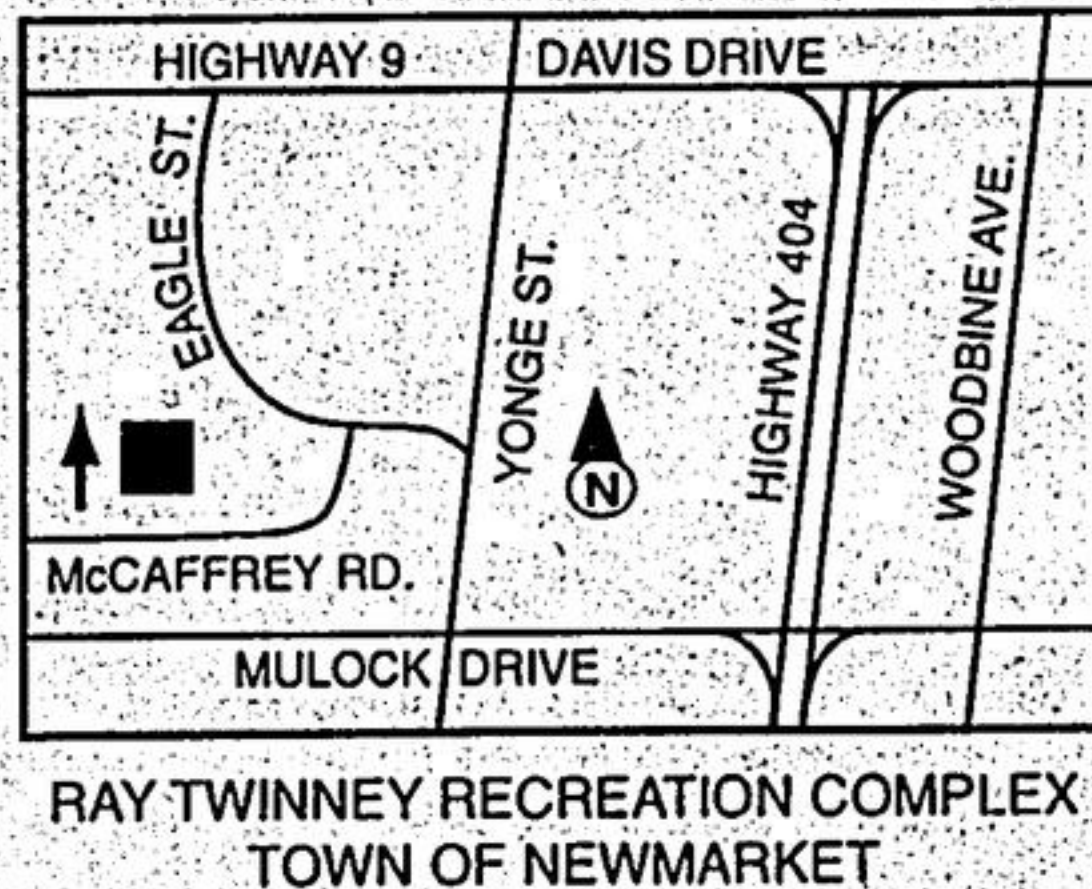
What to do:

- Make sure all materials are in original containers or contents are very well marked on containers. Do not mix different products together. Be sure that all containers are capped. Please remember that your containers must be deposited with waste materials and are not returnable.
- Bring your household hazardous waste to the Ray Twinney Recreation Complex in the Town of Newmarket.

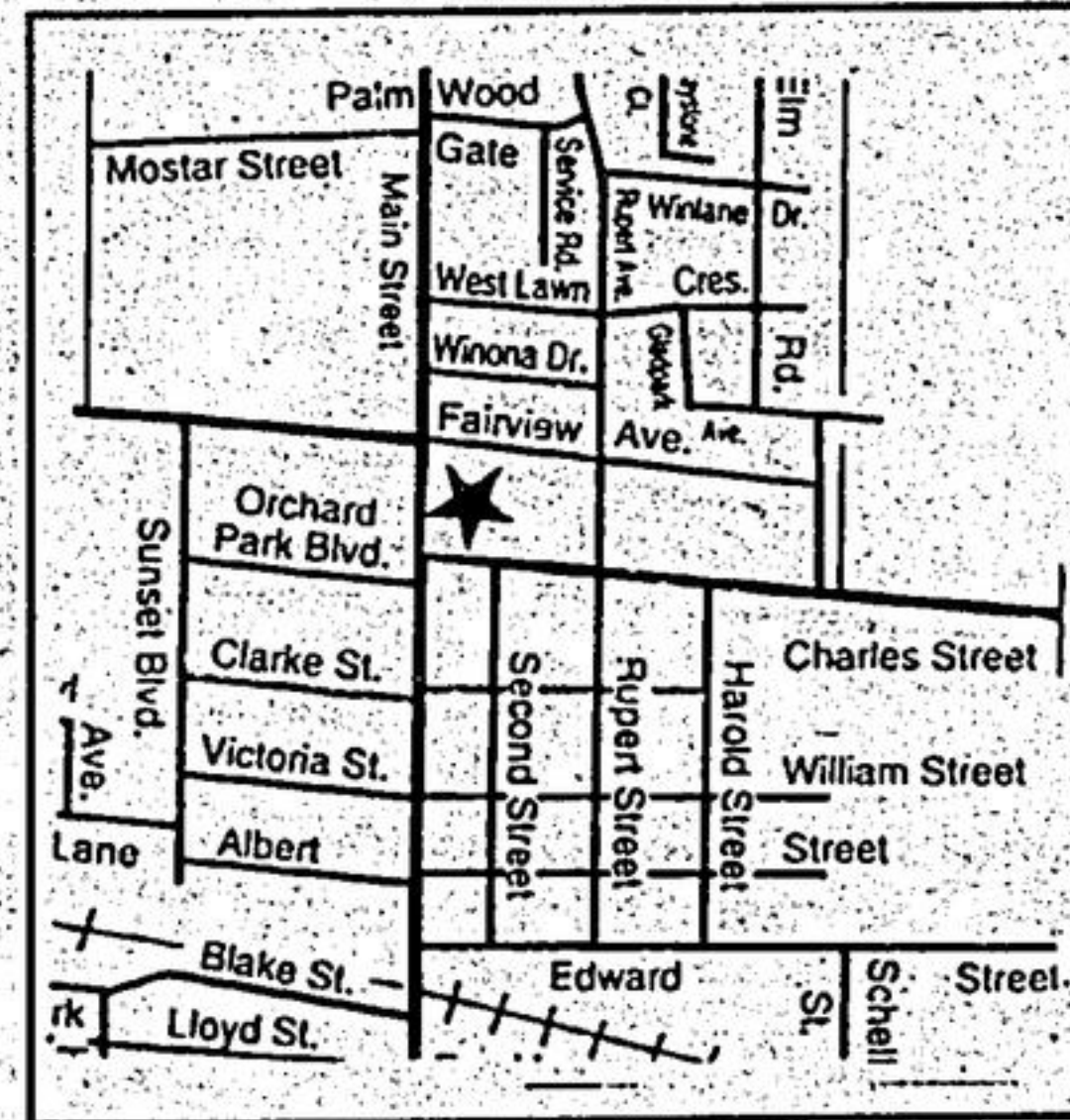
