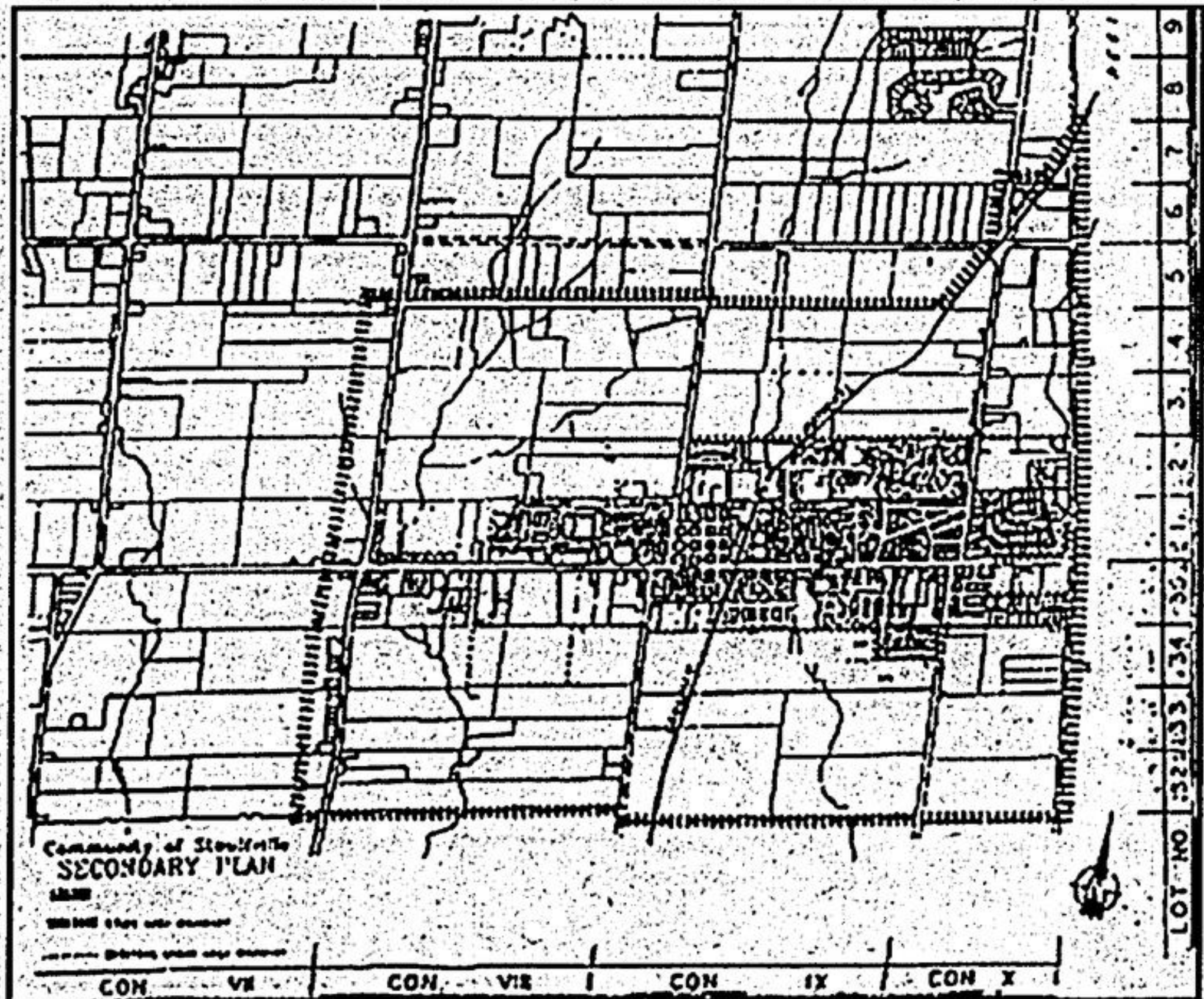
TAKE NOTICE that the Council of the Town of Whitchurch-Stouffville, passed By-law 97-148-OP adopting, Official Plan Amendment No. 101 - **COMMUNITY OF STOUFFVILLE SECONDARY PLAN** on the 14th day of October, 1997 under Section 17 of the Planning Act, 1990.

The Secondary Plan establishes the community vision, principles and objectives as well as general policies and specific strategies with respect to community character, the natural environment, servicing, land use and transportation, for the existing Community of Stouffville and surround area. The amendment area is outlined on the map below. A copy of the Official Plan Amendment is available for inspection in the Planning Department during regular office hours.

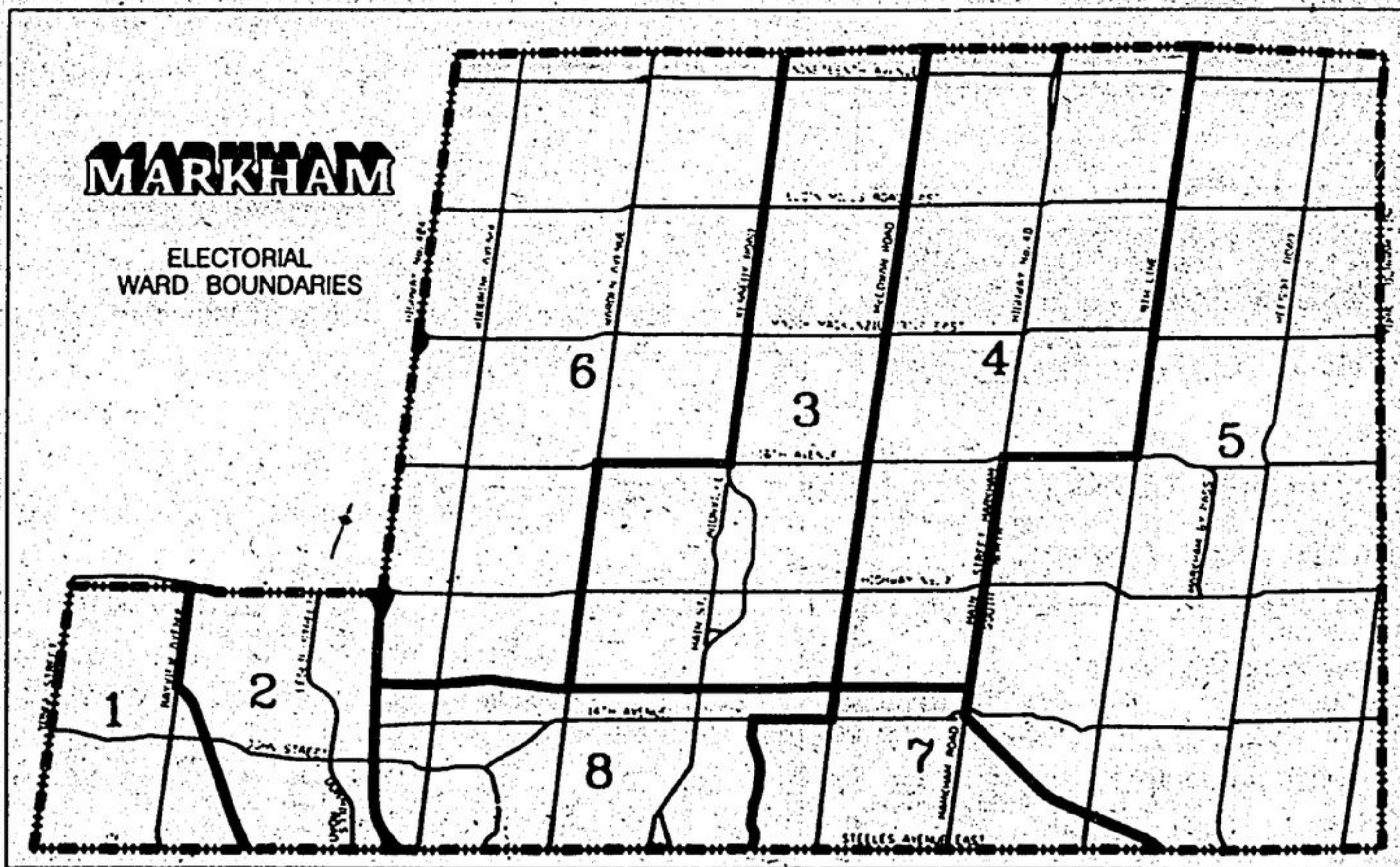
