The Public School Board is required to recommend two representatives. The Separate School Board recommends one representative. A person is qualified to be appointed who:

- (a) is at least eighteen years old;
- (b) is a Canadian citizen;
- (c) is a resident of the municipality for which the Library Board is established;
- (d) is a public school elector (for appointment by The York Region Board of Education); or
- (e) is a separate school board elector (for appointment by The York Region Roman Catholic Separate School Board); and
- (f) is not employed by the Library Board or by the municipality.



