That dropoff was never confirmed by independent witnesses.

Mulholland said all police can confirm is that Pol and Lamondin-Gagnon were last seen together in his car. The vehicle has been seized by police.

The *Tribune* has also learned the missing persons case was turned over to the homicide squad June 3, partially because Newmarket detectives were suspicious of Pol's statements.

And Pol raised eyebrows when he told Grey Goat owner Beau Wasiluk he had seen Lamondin-Gagnon on Main Street on the afternoon of May 30.

Wasiluk said Pol told him about the sighting on June 1, the day after Lamondin-Gagnon's brother reported her missing.

"I found it very difficult to believe," Wasiluk said. "I told him I found it strange that he could see her on Sunday when no one else had seen her since Friday. But he was adamant."

Wasiluk said Pol, who frequented the bar three or four times a week, told him he never stopped his car to talk to Lamondin-Gagnon on the Sunday.

Pol told Wasiluk he reported the sighting to York Regional Police when he learned of the missing persons report on June 1. Wasiluk said that was the last time he came to the Grey Goat.

Wasiluk said Pol started coming to his bar about eight months ago.

Wasiluk said Pol became acquainted with Lamondin-Gagnon at the Grey Goat.

"She is just a great gal, a really good kid," he said. "I think he thought she had broken up with her boyfriend so he was moving in."

Mulholland said police have searched the area near Pol's Vandorf employer and around his Durham Region home for signs of the woman.
