 A zoning By-law Amendment to permit as a Temporary Use, for a period of three years in time, a business that will process carcasses on a custom pre-ordered basis for the farming community as a value added commodity as an additional use on the property. The proposed amendment will restrict the proposed use to the existing building and will specifically prohibit an abattoir and over the counter retail sales.

## 2000 FINAL TAX BILLS

**1<sup>ST</sup> Installment Due - August 18, 2000**

**2<sup>ND</sup> Installment Due - October 20, 2000**

TAX bills have now been mailed. Ratepayers who have not received their bills should make immediate application to the Municipal Tax Department.

**THE PENALTY** charged for non-payment of 2000 taxes is one and one-quarter (1-1/4) percent imposed on the first day of default and on the first day of each month thereafter.

**FAILURE** to receive a tax bill does not eliminate the responsibility for payment of taxes nor the penalty charges for late payment.

**TAX PAYMENTS** may be made by mail, or in person at the Town Office and at most Financial Institutions through tellers, banking machines and by telephone. Banking fees may apply. Penalty will be charged and added to your tax account at our office on payments made at the bank after the due dates. After hours tax payments may be left in the drop box at the front west entrance door of the Imperial Building (37 Sandiford Drive).
