INFORMATION MEETING

Hamlet of Bloomington Municipal Water System

The Council of the Town of Whitchurch-Stouffville will be hosting an Information Meeting concerning the present status of the Hamlet of Bloomington Municipal Water System on Monday September 18th, 2000 at 7:00 p.m. at the Town Municipal Offices, Council Chambers.

The purpose of this meeting is to appraise the area residents of Bloomington of the following:

- review the present status of subdivision files within the hamlet area;
- outline the summary conclusions arising from the completion of the Class Environment Process (conducted by the Region of York Region and the Town) which examined the feasibility and implications arising from the extension of the water system southerly from the water tower at Musselman's Lake to the Hamlet;
- outline the various financial recovery models which are available to the Town to fund the capital costs associated with the installation of the water supply system; and
- outlined the anticipated project timetable for the installation of the water supply system.

A question and answer period will follow the presentations to allow area residents the opportunity to seek further information or clarification with respect to issues surrounding the proposed Bloomington Municipal Water System.

Residents are advised pursuant to Section 32 of the Municipal Elections Act, R.S.O., 1990, c. M.53, as amended, that nominations of the candidates in the election for the offices set out below may be filed in the Clerk's Office, 37 Sandiford Drive, 4th Floor, Stouffville, during regular office hours of 8:30 a.m. to 4:30 p.m. (local time) and on "NOMINATION DAY", Friday, October 13th, 2000 between the hours of 9:00 a.m. to 5:00 p.m. (local time). A prescribed nomination filing fee (\$100 cash) and a \$200 deposit for election signs must accompany the nomination form. A nomination must be certified by the Clerk before such person becomes a certified candidate for the office to which she or he is nominated.

The offices for which candidates may be nominated are:

- OFFICE OF MAYOR** - one (1) to be elected at large;
- OFFICE OF WARD COUNCILLOR** - one (1) to be elected from each of the six (6) Wards;
To compose the Council of The Corporation of the Town of Whitchurch-Stouffville for a three (3) year term commencing December 1st, 2000. Persons to be nominated to any of these offices must file their nominations with the Clerk of the Town of Whitchurch-Stouffville, 37 Sandiford Drive, 4th Floor, Stouffville, during the above noted times.
- OFFICE OF MEMBER TO THE ENGLISH LANGUAGE YORK REGION DISTRICT SCHOOL BOARD** - One (1) member to be elected by public school electors to represent the Towns of Whitchurch-Stouffville and East Gwillimbury. Persons to be nominated to this office must file their nominations with the Clerk of the Town of Whitchurch-Stouffville at 37 Sandiford Drive, 4th Floor, Stouffville, Ontario during the above-noted times.
- OFFICE OF MEMBER TO THE ENGLISH LANGUAGE YORK REGION CATHOLIC DISTRICT SCHOOL BOARD** - One (1) member to be elected by separate school electors to represent the Towns of Aurora, King and Whitchurch-Stouffville. Persons to be nominated to this office must file their nominations with the Clerk of the Town of Aurora at the Civic Centre, 100 John West Way, Aurora, Ontario during the above-noted times.
- OFFICE OF MEMBER TO THE FRENCH LANGUAGE PUBLIC DISTRICT SCHOOL BOARD** - One (1) member to be elected by French language public school electors to represent all of the municipalities within York Region. Persons to be nominated to this office must file their nominations with the Clerk of the Town of Markham at the Civic Center, 101 Town Centre Blvd., Markham, Ontario, L3R 9W3 during the above-noted times.
- OFFICE OF MEMBER TO THE FRENCH LANGUAGE CATHOLIC DISTRICT SCHOOL BOARD** - One (1) member to be elected by French language Catholic electors to represent all of the municipalities within York Region. Persons to be nominated to this office must file their nominations with the Clerk of the Town of Markham at the Civic Centre, 101 Town Centre Blvd., Markham, Ontario, L3R 9W3 during the above-noted times.

ONLY NOMINATION PAPERS IN THE PRESCRIBED FORM MAY BE USED AND ARE AVAILABLE AT THE MUNICIPAL OFFICE IN STOUFFVILLE.

If more qualified Candidates are nominated for the respective offices than are required to fill same, the ELECTION will be held on

MONDAY, NOVEMBER 13TH, 2000
from the hour of 10:00 a.m. until 8:00 p.m. (local time)

with advance vote on Saturday, November 4th, 2000 (10:00 a.m. - 6:00 p.m. local time) and Monday, November 6th; Tuesday, November 7th; and Wednesday, November 8th, 2000 (4:00 p.m. - 8:00 p.m. local time). Locations to follow.

Where the number of qualified Candidates nominated at the end of Nomination Day is not sufficient to fill the number of vacancies, the Clerk may receive and certify additional nominations for the office for which there was an insufficient number of Candidates on Wednesday, October 18th, 2000, between the hours of 9:00 a.m. and 5:00 p.m. local time.

NOTICE OF THE PASSING OF A ZONING BY-LAW BY

THE CORPORATION OF THE TOWN OF WHITCHURCH-STOUFFVILLE

TAKE NOTICE that the Council of The Corporation of the Town of Whitchurch-Stouffville passed By-laws 2000-139-ZO and 2000-140-ZO on the 5th day of September, 2000, under Section 34 of the Planning Act 1990.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the by-law(s) by filing with the Clerk of The Corporation of the Town of Whitchurch-Stouffville not later than the 4th day of October, 2000 a notice of appeal setting out the objection to the by-law(s) and the reasons in support of the objection. In accordance with Section 34(19) of the Planning Act the notice of appeal must be accompanied by the Ontario Municipal Board Act prescribed fee of \$125.00, payable to the Minister of Finance.

NOTE: Only individuals, corporations and public bodies may appeal a zoning by-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group.

EXPLANATORY NOTE BY-LAW NUMBER 2000-139-ZO
