THE FINAL INSTALMENT OF REALTY TAXES IS DUE OCTOBER 18TH, 2002

AND

2002 FINAL COMMERCIAL, INDUSTRIAL & MULTI-RESIDENTIAL TAX BILLS

1st Instalment Due - October 18, 2002

2nd Instalment Due - November 15, 2002

COMMERCIAL, INDUSTRIAL & MULTI-RESIDENTIAL TAX bills have now been mailed.

Ratepayers who have not received their bills should make immediate application to the Municipal Tax Department.

THE PENALTY charged for non-payment of 2002 taxes is one and one-quarter (1 1/4) percent imposed on the first day of default and on the first day of each month thereafter.

FAILURE TO receive a tax bill does not eliminate the responsibility for payment of taxes nor the penalty charges for late payment.

TAX PAYMENTS may be made by mail, or in person at the Town Office and at most Financial Institutions through tellers, banking machines and by telephone. Banking fees may apply. Penalty will be charged and added to your tax account at our office on payments made at the bank after the due dates. After hours tax payments may be left in the drop box at the front west entrance door of the Imperial Building (37 Sandiford Drive).

YARD WASTE/LEAF COLLECTION

Residents are advised that starting this fall, leaves will only be collected if they are in clear plastic bags, paper bags or reusable open top containers (excluding cardboard boxes) such as bushel baskets or garbage cans.

The Town will no longer be picking up leaves raked, blown or piled along the roads.

Non-containerized or non-bagged leaves present a traffic and drainage hazard and residents are required to remove them.

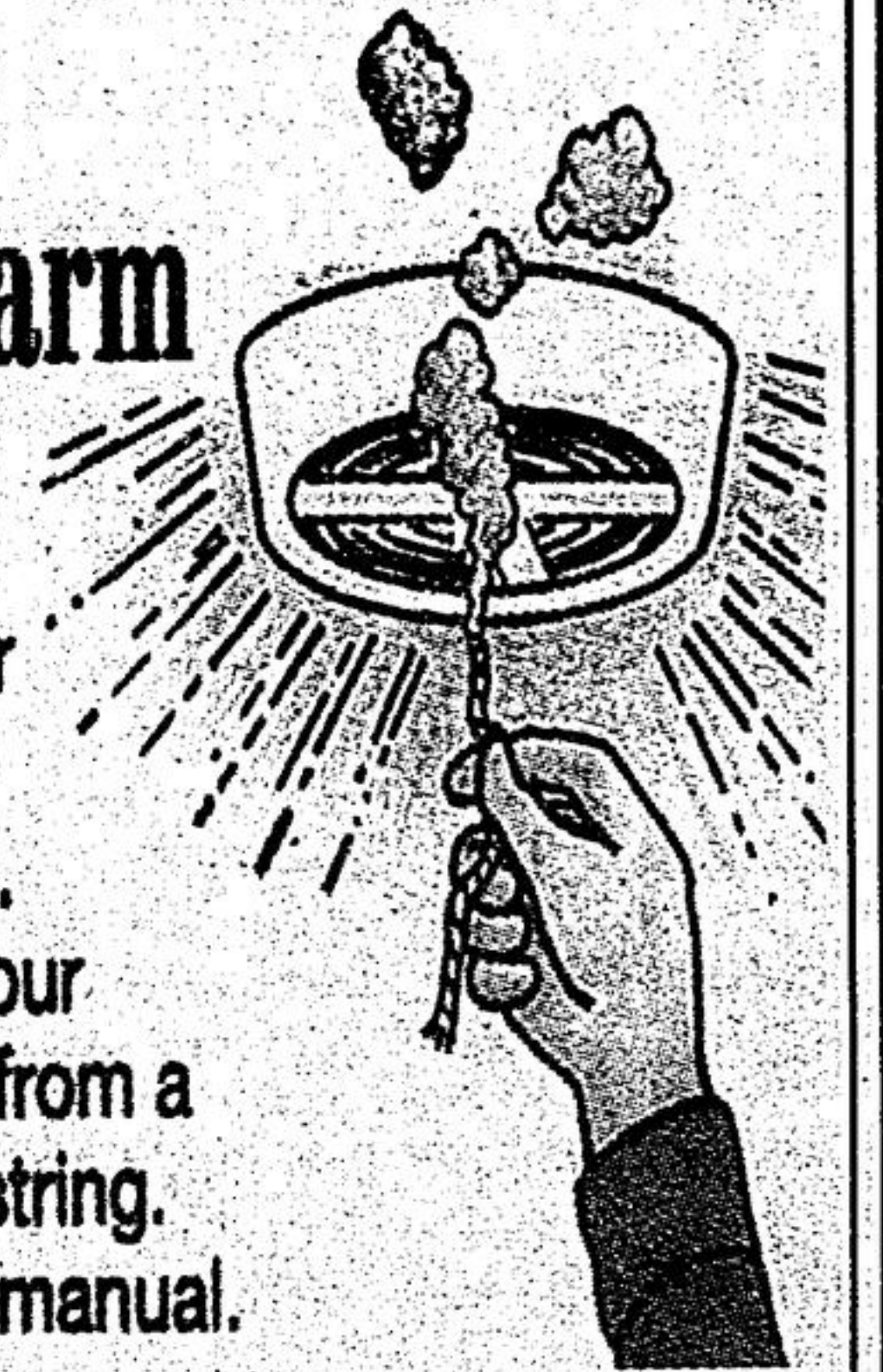

WATER DISTRIBUTION FLUSHING PROGRAM COMMUNITIES OF BALLANTRAE & MUSSELMAN LAKE

The Public Works Department reminds residents that it is conducting routine flushing operations of the Ballantrae/Musselman Lake municipal water distribution system.

The next flushing of the system is scheduled to resume on **Monday October 21st, 2002** and will be conducted between the hours of 9:00 a.m. and 3:30 p.m., and will be repeated every three (3) weeks until further notice.

This flushing is necessary to simulate normal operation of the system.

COMMUNITY OF STOUFFVILLE

The Public Works Department will be conducting a watermain flushing program throughout the Community of Stouffville, commencing Monday October 21st, 2002. This work will be conducted between the hours of 9:00 a.m. and 3:30 p.m. and is expected to last until approximately **Friday November 1st, 2002.**

During the flushing operation discoloration of the water may occur and because of this we ask for your assistance by restricting the use of water to a minimum while the work is being conducted. Should discoloration of the water occur after the work has been completed let water run until it clears.
