#### Stouffville mayor's town hall renovation estimate is correct

*Re: Why is renovation bill so high? Letter to the editor by Pam Mandich, Oct. 17.*

In response to Ms Mandich's letter questioning the estimated costs involved to restore Stouffville's Old Town Hall, the mayor's estimate of \$1.2 million is a reality, not an figure thrown out by an uninformed source.

For the record—and these figures are available to anyone who took the time or bothered to investigate—the estimated costs associated with our original proposal to restore the building were indeed \$770,000 excluding taxes.

This was based on our analysis of the work which would be required and subsequently confirmed through estimates obtained from a general contracting firm quite familiar with heritage restoration work.

This estimate did not include any interior main floor renovations which would have been done through leasehold improvements. It did not include an elevator to the second floor, since the second floor would have operated independently, and it did not include any design, engineering, and project management fees which we were planning on absorbing through our company.

Further, the estimates were based on a private firm doing the restoration which would have permitted us to shop for the best possible prices for the various phases of the project and use local contractors.

It should also be noted the cost estimates obtained by the previously involved theatre group were very close to our figures.

During our discussions with the Town during the summer wherein it would retain possession of the main floor, it was determined the cost associated with the main floor interior renovations, and 50 per cent of the design, engineering and project management fees would be approximately \$205,000.

This figure is based again on our analysis as well as information obtained from a general contractor. This brought the total to \$975,000.

Adding an elevator to the equation at approximately \$40,000 brought the total to \$1,015,000. Add taxes of \$152,250 onto that figure and the total is \$1,167,250.

As far as I can tell, Mayor Emmerson has acted in a morally and fiscally responsible manner by providing the taxpayers of this community with these facts.

#### Thanksgiving food bank campaign had its flaws

It is with grateful hearts that the executive of the Whitchurch-Stouffville Food Bank thanks the community for its response in donations to the local food bank.

The generosity of the people in this town is always overwhelming. The donations come regularly throughout the entire year and we really have no need to "beg" of you to give.

We are always sad, however, when things are printed in the local papers from higher powers that don't really know this community.

This year we became part of the Thanksgiving food drive of which we did not wish to be, and which we had asked not to be involved in. The Ontario Food Bank Association, along with the Grocery Industry Foundation, planned and executed the entire campaign.

The part that disturbs us most were the coupons in stores asking you to add \$2 to your grocery bill for the local food bank. What they neglect to say was the money was returned by the stores to the Grocery Industry Foundation, then passed on to the Ontario Association of Food Banks.

This association deducted 10 per cent from each donation to cover the cost of administration of the food drive and another five per cent for the regional hub food banks helping to co-ordinate things in the regions.

Eighty-five cents of each dollar was returned to the local food bank.

We are deeply disturbed over such campaigns, especially those for which we have no control. Whitchurch-Stouffville has been extremely supportive for the past 12 years and the food bank has been a blessing to many families in need.
