YORK REGION TRANSIT FARE CHARGE FOR JANUARY 2005

Effective January 1, 2005, York Region Transit (YRT) will be standardizing cash fares for all YRT riders, including adults, seniors, students and children. All cash fares will be \$2.25, with the exception of Express bus fares, which will remain \$2.50. This restructuring will bring YRT cash fares more in line with other Greater Toronto Area (GTA) transit services.

All riders can still take advantage of a variety of discounted fare options including tickets and monthly passes. Discounted tickets and passes are valid on all YRT services. TTC contracted services operating within York Region, the Newmarket B GO Bus service (traveling within Newmarket and Aurora with applicable supplement) and Brampton Transit buses operating within York Region.
