

Robert Bateman in Stouffville

Celebrated artist and naturalist Robert Bateman will be in Stouffville Saturday.

He will be at Golden Eagle Art Gallery, at Main Street and Ringwood Drive, from 3 to 5 p.m.

Mr. Bateman, 77, was inspired by the Group of Seven. He taught high school in Ontario and Africa for 20 years, including three years at Thornhill High School.

He hosted his first major one-man exhibition in 1977.

His work gained prominence in the 1970s and '80s. His show at the Smithsonian

Institute in Washington, D. C., in 1987 drew record crowds.

Mr. Bateman, whose art reflects his commitment to ecology and preservation, has been a spokesperson for many environmental and preservation issues.

The Toronto native has three schools in this country named after him.

He lives on Salt Spring Island in British Columbia.

NOTICE OF STUDY COMPLETION WESTHILL DEVELOPMENTS (LEBOVIC ENTERPRISES LIMITED) AURORA, ON

Westhill Developments Limited (Lebovic Enterprises Limited) has submitted development applications for a 75 unit condominium single family residential development east of Leslie Street and a golf course development east and west of Leslie Street, both north of Bloomington Road in the Town of Aurora. It is proposed that the development be serviced with:

- a new communal wastewater treatment system
- a new communal water supply system
- improvements to Leslie Street to meet current Regional standards
- a new golf cart crossing of Leslie Street and
- on-site storm water management facilities

These applications have been referred to the Ontario Municipal Board (OMB) for a decision under the Planning Act. The OMB hearing on the applications is scheduled to commence on Monday, April 7, 2008.

Planning Act and Class Environmental Assessment

In accordance with the Environmental Assessment Act (EA Act, O. Reg. 345/93) the Proponent is required to undertake an environmental planning process related to the infrastructure noted above.

Westhill Developments, the proponent of these projects has used the "integrated approach" set out in Section A.2.9 of the Municipal Class EA, 2000 as amended in 2007. This process included two public consultation sessions, contact with approval agencies and municipalities and culminated with the preparation of the "Westhill Environmental Study Report November, 2007". This report was prepared in accordance with the Class EA and outlines the study purpose, alternative solutions, environmental effects and the preferred solution for each project.

This report is available for public review and comment before the OMB holds its hearing and renders its decision. In accordance with the integrated approach, once the proponent has satisfied Section A.2.9 of the Class EA, the Planning Act approval of the development, if granted by the OMB, will constitute the fulfillment of the requirements of the EA Act for the specified projects. The proponent may proceed to construct the projects in accordance with the approvals given.

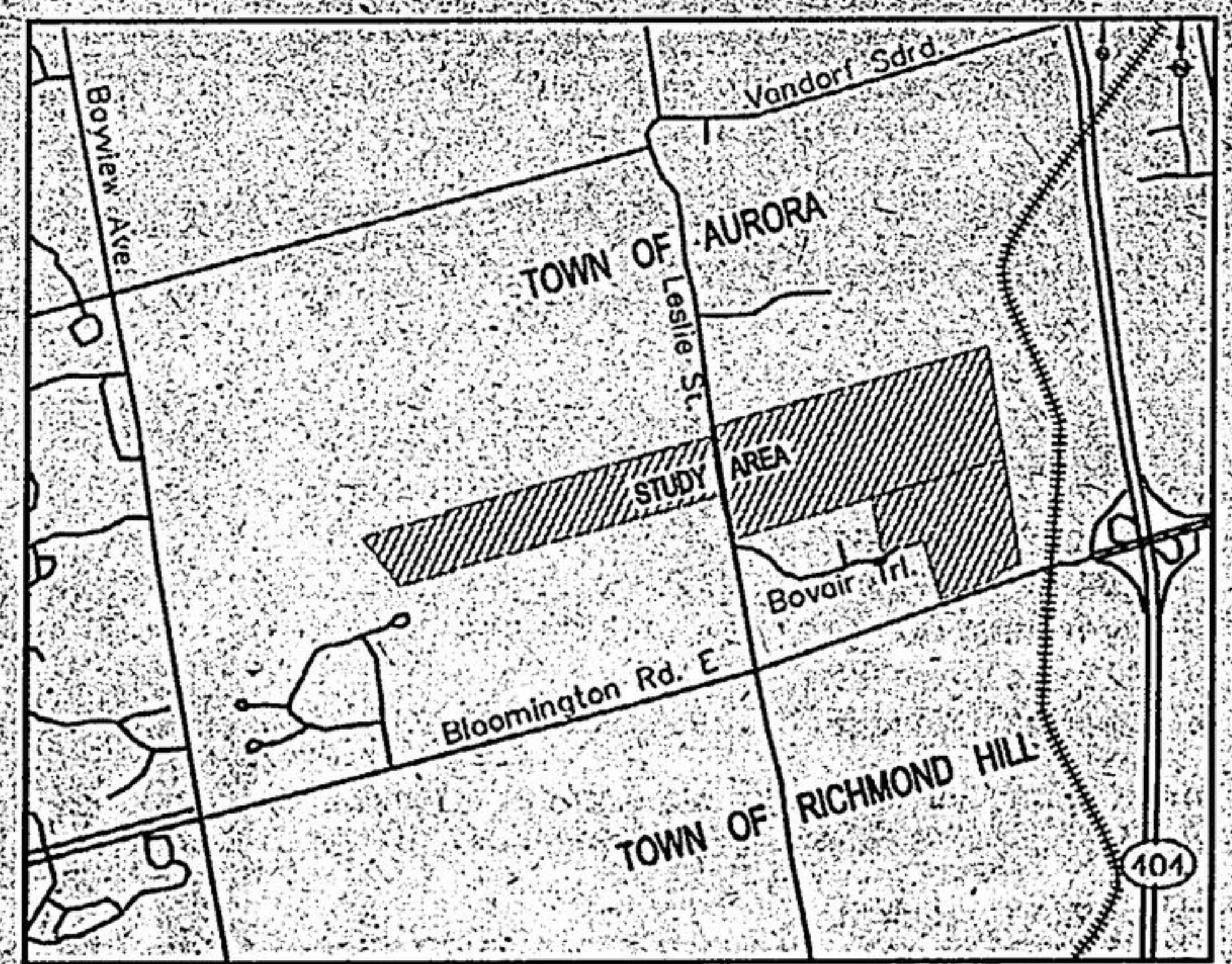
