Plan 838 new homes

MARKHAM - Draft plans for three subdivision sites, Ninth Line, south of Hwy. 7, have been approved by the Markham; Planning Committee.

When completed, the 838 homes will accommodate approximately 3,000 persons.

In discussing the issue at a meeting, Jan. 20, Murray Henderson, councillor, Ward 5 warned against making the same error as occurred in Sherwood Heights'. He asked for a guarantee that the homes in the new area would have a minimum floor space of 2,000 square feet. He argued that 1,200 and 1,300 square feet, as allowed in Sherwood Heights, failed to produce sufficient assessment and represented only a 'tax burden' on the rest of the town.

Rabies warning

STOUFFVILLE - Skunks are the most prevalent carriers of .. rabies, and the winter period is the most dangerous season of the year, Dr. Terence O'Connor, Stouffville Veterinary Clinic told The Tribune this week.

He said one such case had been reported at Goodwood and two dogs had subsequently been placed under quarantine. The animal was killed.

Dr. O'Connor's information supports a recent appeal by the Ontario Dept. of Lands and Forests, urging parents to warn their children against contact with any wildlife that may

appear friendly or extremely aggressive. Check out any reports about the new 'kitty' or 'doggy' in the front yard, the report goes on, remember a rabid animal's bite can cause illness and even death.

Rabies in foxes is just as prevalent as in skunks, the Department points out, but foxes usually are restricted to more rural areas. If you have reason to believe an animal is infected, call the nearest office of the Canada Department of Agriculture or the Ontario Department of Lands and Forests for further directions, the report concludes.

Snowmobile bylaw

Uxbridge rejects \$25 licence fee

GOODWOOD -- A \$25 municipal licence fee for all snowmobile owners in Uxbridge Township?

No, replied members of council, at a meeting, Monday. While council agreed that some controls were necessary and had instructed their solicitor to prepare such a bylaw, they felt an additional permit was much too costly and restrictive.

The bylaw further recommended that no snowmobiles be allowed to operate between the hours of 12 midnight and 8 a.m. and that no owner of a private park, country club or ski resort should allow such vehicles to operate at any time.

Bylaw Enforcement Officer, Stuart Copping agreed that the suggested regulations were not satisfactory.

YORK REGION - The pregnancy rate among students in the secondary school level of education is increasing and the incidence of venereal disease has reached such epidemic proportions that teachers of District 11, Ontario Secondary School Federation have called for the creation of birth control information centres and clinics, beginning in the first year of high school or earlier.

The recommendation, in the form of a motion, was approved at a meeting, Jan. 21, in Aurora. It will now be passed to the Provincial Annual Assembly in -Toronto, in March.

Loss exceeds \$2,000

Sheep flock ravaged in pen; one dog shot

Second dog captured

MARKHAM - Members of Markham Town Council, department employees and neighbors stood in silence, Sunday, as one by one, fifteen sheep were removed from a pen on the farm property of Harvey Brown, Hwy. 48 at 18th Avenue.

All were dead, horribly mutilated by dogs, in the most destructive slaughter of livestock witnessed in the Markham area in years.

Three others, still alive, but badly torn, had to be destroyed. Forty-three were injured.

The loss, estimated in excess of \$2,000, cannot be fully determined since all the ewes were in lamb. The flock totalled 175.

The grizzly discovery was made by Mr. Brown himself, in a routine check of the enclosure after returning home from church. One dog, a German Shepherd, was still in the pen. Mr. Brown ran to the house for a gun and killed it with a single shot. A second was traced across the fields and captured by canine control officer, Jas. Ryan. Chunks of wool were still in its mouth.

The sheep considered worth saving were stitched up and injected with an antibiotic to reduce the chance of infection. Veterinarian, Dr. David Harris of Stouffville was assisted by Harvey's brother, Gordon; Howard Stiver and Bill Shearn of Unionville and Markham livestock valuator, Donald Boynton of Victoria Square. Mr. Boynton described it as 'the worst mess he had ever seen'. Also on hand were councillors Bud Bonner and Norm Tyndall and deputy-

clerk Neil Brodie. In spite of the setback, Mr. Brown is determined to remain in the sheep business. The entrance to the enclosure was barricaded, the owner said, but the dogs pushed it aside and vaulted a horizontal gate.

A prominently placed sign near the door of the pen read 'No trespassing without permission'.
