### Passenger robbed

STOUFFVILLE - York Regional Police have issued a warrant for one man, and are searching for two more, in connection with a robbery near

Musselman's Lake. The victim, Grant Roach, Main Street East, Stouffville, told officers, he accepted a ride home, March 31 with three other men. He said the driver stopped the car on a back road and demanded his money, with threat of injury or death.

The thieves made off with about \$20.

On Tuesday, police arrested Edward Russell Smith, age 20, of Stouffville. He is charged with robbery.



# 63% opposed, survey reveals

STOUFFVILLE. - Sixty-three percent of Stouffville residents replying to a questionnaire concerning the proposed airport project, have stated their opposition to it.

The result, made public this week, follows a survey conducted by Sinclair Stevens, federal Progressive Conservative candidate in the Riding of York-Simcoe.

Thirty-one percent said they favored the scheme while six percent had no opinion.

Of the 2,000 pre-paid postcards provided Stouffville householders, only ten percent were returned.

The majority of opponents based their opinions on fear of noise and pollution. A lesser number felt a second airport was not needed and that present facilities at Malton could be expanded. Some considered it unwise to utilize good farmland for such a purpose while others felt the community's rural-type

### Holiday Inn for Hwy. 48 in Markham?

MARKHAM - Although not - confirmed, The Tribune has learned, on fairly good authority, that a modern Holiday Inn may be constructed at a site near Hwy. 48, south of the old Town of Markham.

The property is said to be close to the C.N.R. overpass, at a location near the intersection of proposed Hwy. 407.

A check with the Building Inspector's Department at Buttonville, revealed no permit for such a structure, has yet been issued.

# Four firms to guarantee million dollars

## Envision 1,000 homes population to 9,000

STOUFFVILLE Four companies, with property holdings extending from Hwy. 47 to west of Conc. 9, including an estimated 300 acres, have banded together and agreed to underwrite an amount of \$1 million for services, both water and sewage, in the former village of Stouffville.

The proposal, explained by solicitor Gary J. Smith, before a special meeting of Council, March 29, would, if approved, create 1,000 new residential lots and also allow homes to be built on fill-in lots, already available.

While the program would be phased over a period of several years, it would, when completed, raise Stouffville's population to about 9,000.

The town's share of the servicing cost has been estimated at \$300,000. The channelization of Duffin's Creek and an addition to the sewage disposal plant is included in the scheme. The acquisition of some of this

land dates back to 1968, Mr. Smith recalled, but only through a co-operative arrangement with four, and possibly five firms, could the payment, on a per lot basis, become practical. He described the developers' \$1 million dollar offer as 'the breaking point':

The companies involved are -Dulverton Holdings Ltd., Fryn Investments Ltd., Stouffville Developments Ltd., and Suncrest Construction Limited. All land lies north of Main Street, from the Gar Lehman farm to north of St. Mark's Separate School. The Plan, at this point, includes only single-family lots.

Mayor Ken Laushway informed the spokesman that the Region of York would enter into the discussion, also the Metro Toronto and Region Conservation Authority. He promised to acquaint all levels of government with the terms of the proposal so that an agreement might be drawn up as soon as possible.

Councillor Gordon Ratcliff was favorably impressed. "It's what we've been waiting for," he said.

He questioned the solicitor, however, concerning what deteriorating effect, if any, the proposed airport might have on a development of such size.

Mr. Smith replied that he retained no concern whatsoever. "We're quite optimistic," he

MARKHAM - The creation of a city of 200,000 people, in a mainly rural area, is one mistake, M.P.P., Donald Deacon (York-Centre) told The Tribune this week. But to call it Cedarwood, is error number

"I will do everything I can to stop it," Mr. Deacon said. He said the location was based entirely on economics, due to the proximity of Lake Ontario for sewer and water service.

As for the name, the local Member said that Cedar Grove, with a proud past, deserved a better fate. "Call it Cedar Grove or Whitevale or something that relates to the area that now is," he said, "Cedarwood means nothing".

Mr. Deacon agreed with a recent Tribune editorial, that the airport site should also be shown the same consideration. He said the name Claremont or Brougham would be far more appropriate than Toronto.
