REMOVAL OF SNOW & ICE FROM SIDEWALKS

The Town is requesting your cooperation to clear away snow and ice from sidewalks abutting your property. Town regulations provide that snow and ice be removed from sidewalks within 12 hours after a snowfall.

COMMUNITY LEAD TESTING PROGRAM

The Town is seeking assistance from residents to meet new provincial water quality legislation. The legislation requires that private residential plumbing and municipal water systems be tested for the presence of lead.

Testing is to take place in both the communities of Stouffville and Ballantrae/Musselman's Lake and residents are encouraged to take part in the Town's volunteer lead testing program. Priority will be given to older homes which may have private lead water services or plumbing. This program will involve testing tap water twice a year in the volunteer's home. All sampling will be undertaken by identified Town waterworks staff members.

Although the Town has a long-standing practice to replace lead pipes within its distribution system, there may be some, privately-owned lead pipes connected to the Town's water system which homeowners have not replaced. Also, there may be lead pipes or plumbing present within a home. OVERNIGHT PARKING

During the months of December through March, no parking is permitted on Town roads between 2 a.m. and 5 a.m. to allow for snow removal. Vehicles parked on roads during this time will be issued a parking infraction notice and fined \$35.00.

CHRISTMAS TREE COLLECTION

Christmas Trees will be collected on Monday January 14th, 2008 only for all areas.

Trees greater than 1.8 metres (6 feet) in height are to be cut in half for easy disposal. PLASTIC BAGS AND DECORATIONS MUST BE REMOVED.

Please have trees placed curbside by 7:00 am on your collection day. Thank you for your co-operation in licensing your dog.

2008 MONTHLY PRE-AUTHORIZED TAX PAYMENTS

The Municipality offers a pre-authorized payment plan for taxes whereby, tax payments are automatically taken from your bank account for ten (10) months. Payments are taken the last business day for 10 months, January to October. The first five payments are calculated on the total 2007 taxes levied. Once the tax rate has been determined the remaining five payments would reflect any increases. Your property must be fully assessed to qualify for this payment method. To qualify for 2008 taxation year, applications should be in the Treasury Department by January 4th, 2008. During the Christmas closure, forms can be mailed or deposited in our drop box at 37 Sandiford Drive.
