## COUNCIL HIGHLIGHTS JANUARY 15, 2008

### NEW OPERATIONS CENTRE

#### CLASS ENVIRONMENTAL ASSESSMENT

Council was provided with an update on the progress of a class environmental assessment required for the development of a new operations centre for the Town. Council also approved the location of the new operations centre on lands at the south side of Bethesda Road west of Highway 48.

The current operations centre, located at 5827 Main Street in the Community of Stouffville will become insufficient as the Town continues to grow. It is anticipated that the new centre will accommodate Public Works and Leisure department staff, vehicles, equipment and materials storage for the maintenance of assets. An environmental assessment is a statutory process which evaluates the impact of development project options relative to social, environmental and cultural factors.

#### COMMUNITY SATISFACTION SURVEY

Council heard a presentation from the Town's consultant, DPRA regarding the launch of the Community Satisfaction Survey. The Survey will be a telephone-based, random survey of 500 residents throughout the Town to determine the satisfaction with Town services. Calls will occur the last week of January through February. The purpose of the Accessibility for Ontarians with Disabilities Act, 2005 (AODA) is to achieve accessibility for Ontarians with disabilities with respect to goods, services, facilities, accommodation, employment, buildings, structures and premises on or before January 1, 2025, by developing, implementing and enforcing accessibility standards. In 2001, The Ontarians with Disabilities Act (ODA) mandated that all municipalities prepare annual accessibility plans. To this end, the 2008 Town of Whitchurch-Stouffville Annual Accessibility Plan aims to describe barrier removal initiatives accomplished in 2007 and outline measures to be taken in 2008 to identify, remove and prevent barriers to people with disabilities.

Small amounts of shredded paper, soiled food packaging such as pizza boxes, diapers, hair, nail clippings, sanitary products, tissues, animal waste, cat litter, food scraps including meat products, baking ingredients including eggs and shells, houseplants, including soil.

### What types of things do not go in the Green Bin?

Fireplace or BBQ ashes, wood, cigarette butts, tobacco, gum, popsicle sticks and toothpicks, ear cleaners, cotton balls, make-up removal pads, dental floss, dryer sheets and lint, baby wipes, vacuum bags and contents.
