CLASS ENVIRONMENTAL ASSESSMENT - NEW OPERATIONS CENTRE

The Town of Whitchurch-Stouffville has completed a Class Environmental Assessment (EA) for a new operations centre. As part of the EA process, the preferred location was identified, that being Part of Lots 4 and 5, Concession 7, Township of Whitchurch, Town of Whitchurch-Stouffville, Regional Municipality of York—located on the South side of Bethesda Road, about 500m West of Highway 48.



The Study has been conducted in accordance with Schedule C of the Municipal Class Environmental Assessment (June 2000) under the Ontario Environmental Assessment Act. The Environmental Study Report has been completed and by this Notice is being placed in the public record for review at the following locations until February 16th, 2008:

Subject to comments received as a result of this Notice and the receipt of other approvals as necessary, the Town of Whitchurch-Stouffville intends to proceed with construction of this project in 2008. **Please provide written comments to Paula Neto, Environmental Transportation Planner, TSH, 300 Water Street, Whitby, ON, L1N 9J2 within 30 calendar days from the date of this Notice (by February 16th, 2008).**

If concerns cannot be resolved through discussions with the Town of Whitchurch-Stouffville, a person may request the Minister of the Environment issue a Part II Order to this project. **A Part II Order request must be received by the Minister at the address below no later than 4:30 pm (local time) on February 16th, 2008.** A copy of the request must also be sent to the Town Clerk. If no request is received by February 16th, 2008, the new operations centre will proceed to detailed design and construction as outlined in the Environmental Study Report.

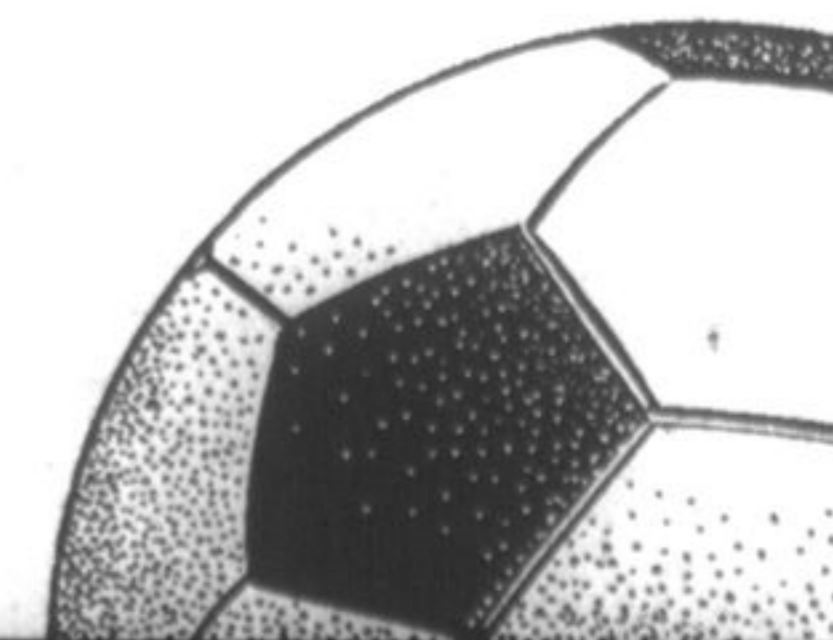
