**COUNCIL HIGHLIGHTS JANUARY 29/08**

Council, at its January 29, 2008 meeting approved the Operating and the Capital budgets for the Town of Whitchurch-Stouffville, totalling approximately \$29 million and \$46 million respectively. In addition to the 2008 Operating and Capital budgets, Council received the Five-Year Capital Forecast for the years 2009 to 2012, to be reviewed again by Council this year. This was achieved with a residential tax increase of 5.9%.

The Town of Whitchurch-Stouffville also collects taxes on behalf of the Region of York and the York Region Boards of Education, as required by legislation.
