## Storyteller weaving Biblical tales at library

Janice Turner talks about women of the Bible, a female perspective, at the Whitchurch-Stouffville Public Library April 17.

Her passion is telling stories of strong, witty and wise maidens, mothers and crones, she said.

A storyteller for 18 years, she has been leading workshops for teachers and students, telling her stories to

groups of schoolchildren and at festivals around Ontario.

In recent years, she has been researching the women of the Old Testament, whose voices have too often been silent, she believes.

At the library, she will tell the stories of Sarah and Hagar, who were the mothers of two great nations, from their point

of view. She has researched the Bible and other literature to allow her to make these characters come alive.

Ms Turner started the Storytelling Tree in Newmarket several years ago, which held monthly meetings for people to tell their stories or come to listen.

Ms Turner will be at the library from 7:30 to 8:30 p.m. Admission is free.

The library is in the Lebovic Leisure Centre at 30 Burkholder Ave., Stouffville.

The principal purpose of the collection is to assess eligibility for the issuance of a liquor sales licence. Copies of all objections are given to the applicant. The information may also be disclosed pursuant to the *Freedom of Information and Protection of Privacy Act*.
