# MAIN STREET IMPROVEMENT

The Main Street Improvement Project continues in 2008 with the road widening and reconstruction underway and proceeding through the summer and fall.

1. What exactly are the "improvements" planned for Main Street?

Main Street will be completely reconstructed from Highway 48 through to the Ninth Line. The new road will have two lanes in each direction with centre and left-turn lanes. Trees and shrubs will be planted in the boulevards and the raised median. Streetlight illumination will be improved with decorative poles and light standards.

2. Why is the Town doing this work?

The Town is growing rapidly and traffic volumes are increasing as a result. The main roads in Stouffville are already congested and traffic will get worse as growth continues over the next few years. This project will provide for better traffic operations and pedestrian safety, while improving access to local business areas.

3. How long will it take for the construction to be completed?

The Main Street Improvement project is planned in three phases:

- Phase 1, from about 200 m east of Highway 48 to Winona Drive, is currently under construction. Most of the roadworks will be done this year with top-lift asphalt and landscaping to be done next Spring.
- Phase 2, the intersection at Highway 48, will be constructed in 2009. This work will be coordinated with the widening of Stouffville Road from McCowan Road to Highway 48 which is also beginning this summer.
- · Phase 3, the intersection at the Ninth Line, will be constructed by the Region about 2011-2012. The Region is currently re-evaluating the jog elimination of the Ninth Line and will complete the Main Street intersection improvements with its construction in this area.

As construction proceeds along Main Street you will experience delays when traveling. Hoover Park Drive and Millard Street are good alternates to consider. We appreciate your patience and understanding.

### What types of things go in the Green Bin?

- Small amounts of shredded paper
- Soiled Food packaging such as pizza boxes
- Diapers
- Hair, nail clippings
- Sanitary products, tissues
- · Animal waste, cat litter
- Food scraps, including meat products
- Baking ingredients, including eggs and shells
- Houseplants, including soil

### What types of things do not go in the Green Bin?


- Fireplace or BBQ ashes, wood
- Cigarette butts, tobacco
- Gum
- Popsicle sticks and toothpicks
- Ear cleaner, cotton balls, make-up removal pads
- Dental floss
- Dryer lint
- · Dryer sheets
- · Baby wipes
- Vacuum cleaner bags and contents
- Recyclable materials

### Possible reasons your Green Bin was not emptied

- 1. There was a Health & Safety concern. Please ensure all green materials are securely contained in bags that are tied or closed. Please avoid using twist ties.
- 2. Your Green Bin contained materials that are not acceptable in the program (i.e. grass clippings)
- 3. Your Green Bin was overflowing fill the Green Bin just to the top so the lid securely closes.
- 4. Your Green Bin was too heavy. Green Bins must not weigh more than 20 kg/50 lbs. Additional Green Bins can be purchased at the Municipal Office (37 Sandiford Drive, 4th Floor).

Please remember to have your Green Bin at the curb by 7:00 a.m. on your collection day.
